
CITY OF BELLEVUE NEIGHBORHOOD SAFETY, CONNECTIVITY & CONGESTION LEVY **Construction Alert** Lakemont Boulevard SE Repairs & 164th Avenue SE and SE Newport Way Mini-Roundabout

June 2019

Description and benefits

- Lakemont Boulevard SE at Newcastle Golf Club Road. The roadway south of the Coal Creek Natural Area and Red Town Trailhead will be excavated and reinforced to repair the existing roadway settlement.
- Lakemont Boulevard SE at Lewis Creek Culvert Crossing. The existing fill material on Lakemont Blvd northwest of the intersection at 164th Avenue SE will be replaced to preserve and extend the life of the existing culvert.
- Intersection of 164th Avenue SE and SE Newport Way. Construction of a miniroundabout will reduce neighborhood traffic congestion. A section of the water main will be replaced.



What to expect and when

Construction is anticipated to begin in July and be completed by November 2019. More details on traffic control will be known once the contractor's schedule is submitted, but generally it will involve those listed below. Closure dates will be posted on signs prior to the start of construction and on the city's traffic advisories webpage at <u>www.BellevueWA.</u> <u>gov/trafficadvisories</u>.

- Lakemont Boulevard SE at Newcastle Golf
 Club Road. Full roadway closure south of the
 Coal Creek Natural Area and Red Town Trailhead.
 - There will be a 7-day (consecutive) closure period. Exact days will be decided by the contractor. During the closure, traffic will be detoured to Forest Drive SE and Coal Creek Parkway SE.
- Lakemont Boulevard and Lewis Creek
 Crossing. Full roadway closure northwest of the Lakemont Boulevard SE and 164th Avenue SE intersection.
 - There will be a 7-day (consecutive) closure period. Exact days will be decided by the contractor. During the closure, traffic will be detoured to 164th Avenue SE and SE Newport Way.
- 164th Avenue SE and SE Newport Way Mini-Roundabout.
 - Three weekends for a full intersection closure from 9 a.m. on Saturday until 8 p.m. on

Sunday. Vehicle and bicycle traffic will be detoured to south of I-90 via SE Newport Way, Coal Creek Parkway, Forest Drive SE and Lakemont Boulevard SE, and detoured to north of I-90 via 150th Avenue SE, SE 37th Street, SE 35th Place, SE 34th Street and West Lake Sammamish Parkway SE.

- The contractor's normal hours of operation is Monday through Friday, from 7 a.m. to 4 p.m. Lane closures with flagging operations will be allowed Monday through Friday, from 8:30 a.m. to 3:30 p.m.
- Pedestrian access will be maintained.

For your safety

Please use caution and drive, ride and walk safely. Obey flaggers directing motorists.

Funding

As a means to achieve better contract pricing and to avoid detour conflicts, these projects have been combined.

- Lakemont Boulevard SE repairs: Construction funding comes from the city's Major Maintenance Program and Overlay Program. Estimated cost is \$843,686.
- 164th Avenue SE and SE Newport Way Mini-Roundabout: Design and construction funding comes from the Neighborhood Safety, Connectivity and Congestion Levy and Small Diameter Water Main Replacement. Estimated cost is \$688,846.


