1. CALL TO ORDER:

This meeting was called to order at 6:07 p.m. by Chair Bien who presided

A. Roll call of members

No roll call at this meeting, we have enough attendees for a quorum.

B. Adoption of the Agenda

A motion to approve the agenda was made by Mr. Bien. The motion was seconded by Mr. Brewer and the motion carried unanimously.

C. Adoption of the Minutes

Minutes from June 25, 2019 wasn't available for approval. Motion to move this to our next meeting on August 27, 2019

2. ICE BREAKER

Our Vice Chair, Aisha Kabani led us to an interactive ice breaker game on the patio.

3. INTRODUCTION OF STAFF

Brooke Brod from Bellevue Essentials on community development was here to talk about her role and responsibilities for the Environmental Stewardship and neighborhood area planning.

4. UPDATE ON BDAN APPLICATIONS

Ms. Garcia provided an update on the current state of re-appointments of the BDAN members and new applicants for the new term. There are 10 - 12 spots open for re-appointment and new applicants.

- A. Re-appointment forms from current members will be reviewed by the City Manager. Re-appointments will be announced soon.
- B. Deadline for new application is on August 15, 2019. As of July 30, 2019 there are 31 applications received.

Process for selection committee:

- 1. BDAN application cycle is July 1st to August 15th.
- 2. Review by committee from August 16th August 26th. There will be a rubric that will be used to guide committee members in choosing top candidates.
- 3. Recommendations to City Managers by August 27th.
- 4. Selection of new members by September 5th.
- ii. Ms. Garcia also provide the overall timeline that goes all the way to retreat on September 28th.
- a. Mr. Bien asked about how we ensure diversity in selecting candidates.
 - Ms. Garcia indicated that committee will be responsible???
- b. Mr. Wu asked about turns of re-appointment.
 - Ms. Garcia said that it will be a two years term for re-appointment
- c. Mr. Brewer asked about the dates for retreat in September.
 Ms. Garcia confirmed the BDAN retreat will be on September 28, 2019

5. BY-LAWS DISCUSSION

- A. Amendment: Pages 4 article 4, A, 1. all officers elected are required to be severed at least one year on BDAN.
 - In the case of our current secretary Ms. Ross, she was elected to be the secretary even though she joined BDAN as a new member this year. There are various opinions around this matter from the BDAN member. The final vote was to not amend the by-laws and give Ms. Ross the exemption under the circumstances to continue her secretary work.
- C. Ms. Garcia point out another article of the by-laws that needs to be modified to "Members may seek re-appointment....

Team decided to have a review team oversee the changes/modification of the bylaws. They are Adnan Siddiquie, Eloisa Tran, Guang-An Wu, and Mohamed Bakr.

- g. Mr. Siddiquie: Should we ask them (city deportment) to come more than once? Ms. Garcia answered NO. she would like to see the process in which the council /deportment already done their homework. Ms. De La Hoz: People come and talk to us, looking for us to provide feedback. Mr. Bien: please provide your suggestions to CRG group directly. Mr. Austin: People, please remember we only been around for < 3 years. Ms. Garcia restated that please talk to the CRG.
