

# **CONSTRUCTION ALERT**

### **150th Avenue SE Congestion Reduction Project**

#### ROAD IMPROVEMENTS AND WALL REPLACEMENT: 150TH AVENUE SE, SE NEWPORT WAY TO SE 38TH STREET

#### **PROJECT DESCRIPTION**

- Add a 600 foot, southbound right-turn lane at the intersection of 150th Avenue SE and SE Newport Way;
- Install a new sidewalk with curb and gutter next to the new right-turn lane along the west side of 150th Avenue SE;
- Build retaining walls on the west side of 150th Avenue SE at the south end of the project to accommodate the roadway widening; and
- Replace 800 feet of existing rockery on the east side of 150th Avenue SE with a new block wall and provide a new six-foot wide sidewalk with curb and gutter.

#### WHAT TO EXPECT AND WHEN

Construction is anticipated to start in April and last through December 2019. Approved work hours are Monday through Friday, 7 a.m. to 3 p.m. Expect northbound lane closures, 9 a.m. to 5 p.m. and southbound lane closures, 7 a.m. to 3 p.m.

Thank you for your patience during construction. Please be alert when traveling through the construction zone and follow the instructions of flaggers.

#### **PROJECT CONSTRUCTION FUNDING**

Construction funding comes from the city's Capital Investment Program and the Major Maintenance Program. Estimated cost: \$3.2 million.


