Pedestrian & Bicycle Improvements

项目概况

贝尔维尤交通署正在开发一个项目,涉及范围为 112th Avenue NE 的 NE 12th Street 至 SR 520 路 段,以及 108th Avenue NE 的 Northup Way 至城市 北界路段。本项目资金来自于2016年11月由选民投 票通过的税金计划,该计划主要用于改善居住区街 道的安全、连通与拥堵。

项目介绍

本项目计划在道路两侧修建自行车相关设施,新建两 处人行横道,并在 112th Avenue NE 与 NE 24th Street 的交汇路口新增一条北向左转车道。




Overview

The Bellevue Transportation Department is developing a project along 112th Avenue NE from NE 12th Street to SR 520 and 108th Avenue NE from Northup Way to the north city limits. The project is funded by the Neighborhood Safety, Connectivity and Congestion Levy, approved by voters in November 2016.

Project Description

The project will install new bicycle facilities in both directions, two new pedestrian crossings and a new northbound left-turn lane at the intersection of 112th Avenue NE and NE 24th Street.



Bicycle Improvements

New buffered bike lanes will be installed for most of the corridor to provide people with a designated space to ride that is separated from vehicles. Vehicle travel will be maintained in both directions. This project helps to complete a gap in one of the city's eleven priority bicycle corridors, the Lake Washington Loop, providing a connection to Downtown, Northwest Bellevue, the 520 trail and the Eastside Rail Corridor trail.

Pedestrian Crosswalk Improvements

Two new pedestrian crossings will be installed along 112th Avenue NE at locations determined by a pedestrian crossing study: (1) at NE 14th St and (2) near Hidden Valley Sports Park. Both crossings will include marked crosswalks, pedestrian crossing signs, upgraded illumination and rectangular rapid flashing beacons (RRFBs).

Additional Improvements Planned

Other improvements planned for 112th Avenue NE between NE 12th Street and NE 24th Street include sidewalk repair, installing a traffic signal at the 112th Avenue NE/NE 24th Street intersection, and repaving the roadway. At this time, these improvements are anticipated to be designed and constructed in the next three years.

Other 2018 Bike Improvements

Watch for new bike lanes on 108th Avenue NE through Downtown (Main Street to NE 12th Street) and on 108th Avenue NE from NE 12th Street to NE 24th Street.

Estimated Construction Schedule Construction is anticipated to take place in fall 2018.

自行车出行环境改进

本项目将在绝大部分路段修建有隔离带的自行车道, 从而为市民提供与汽车道隔离的理想骑行空间。车辆 交通将维持双向行驶。本项目将填补本市十一条重点 自行车通道之一的华盛顿湖自行车通道的缺口,打通 与贝尔唯尤市中心、城市西北区域、SR 520自行车道 及 Eastside Rail Corridor 自行车道的联系。

人行横道改进

本项目拟在112th Avenue NE 上新建两处人行横道, 根据人行横道研究结果,选址分别为(1) NE 14th St 和(2) Hidden Valley Sports Park 附近。新增 人行横道均将包括斑马线、人行横道标志、照明设施 升级以及矩形快速闪动信号灯(RRFBs)。

后续改进计划

112th Avenue NE 的 NE 12th Street 至 NE 24th Street 路段后续改进还将包括:人行道检修、在 112th Avenue NE 与 NE 24th Street 交叉路口安装交 通信号灯、 以及路面翻新。这些改进有望在未来三 年内完成设计与施工。

108th Avenue NE 市中心路段 (Main Street - NE 12th Street); 108th Avenue NE (NE 12th Street - NE 24th Street)。
