

## SETUP AND PICKUP

- You are responsible for your own tables (tables also available for rent), display pieces, table coverings (floor length only), lights, and cords.
- Okay to restock any time.
- Pick up and clean up Saturday, December 5, 5pm and not before.
- All items not claimed within two weeks following the show will be donated to a local charity.

## BOOTH AND CRAFTS

- Space is limited to 6'x3'. Exceptions apply.
- No "walk-around" booth. Exceptions apply.
- All display pieces must be clearly marked with your name and phone number.
- Booth must have backing such as lattice, fabric, crates, or other. No "flat" table display.
- Energy clip lights required.
- One strand of twinkle lights recommended.
- All merchandise must be handcrafted by the exhibiting vendor.

## PICTURES

- New vendors must submit three or more pictures of craft AND booth display with registration form and entry fee. Websites and email pictures are acceptable.

## VENDOR ID AND CONFIRMATION

- Upon acceptance into the show, confirmation will be emailed after November 1, 2015 with your vendor number, setup date, and time.
- If you do not have a vendor number, one will be issued to you in your confirmation information email.

## EXHIBITOR CHECKS

- Checks will be mailed within fourteen business days following the show.
- Washington state sales tax will be claimed and reported by Hilltop Holiday LLC.

## LIABILITY LIMITATIONS

The City of Bellevue and Hilltop Holiday, LLC will not be responsible for losses due to the following:

- Merchandise or any display items that may be lost, stolen, or damaged in any way.
- Personal injury to the exhibitor during setup, pickup, or during show proceedings.
- Exhibitor will hold harmless the City of Bellevue and all show promoters from any and all liability arising from setup, tear-down, and show proceedings of this event.



- 6 ft. table available for rent for \$10 (add to registration fee).
- Registration form will not be accepted from new vendors without three or more pictures of product and booth display.
- Registration fee does not guarantee specific floor space. We reserve the right to move and alter any and all display pieces and products at any time.
