		4.	Northwest Village - DNTN-MU & R Continued discussion of the PDD, development potential in the area, and character of Downtown Districts.	
		5.	Pedestrian Corridor - DNTN-01 & 02 & MU Discussion of the vision for the Corridor, relationship to the Council priorities and development in the area	
		6.	Old Bellevue - DNTN-OB & MU Discussion of recent development activity, and neighborhood character.


