## Resolution No. 354-A

A RESOLUTION of the East Bellevue Community Council disapproving City Council Resolution No. 5778 amending the definition of Community Business in the Comprehensive Plan of the City of Bellevue, as adopted pursuant to the Growth Management Act of 1990, as amended (chapter 36.70A RCW), and as separately adopted pursuant to chapter 35A.63 RCW, and amending Sections 1 and 2 of Resolution No. 5726.

WHEREAS on the 2nd day of May, 1994, the City Council of the City of Bellevue, Washington passed Resolution No. 5778 amending the definition of Community Business in the Comprehensive Plan; and

WHEREAS, the subject matter of said Resolution falls within the jurisdiction of the East Bellevue Community Council pursuant to RCW 35.14.040; and

WHEREAS, following a public hearing held before the East Bellevue Community Council on June 7, 1994, the Community Council voted in open meeting to disapprove Bellevue Resolution No. 5778;

NOW, THEREFORE, the Community Council of the East Bellevue Community Municipal Corporation of the City of Bellevue resolves as follows:

Section 1: The East Bellevue Community Council hereby disapproves Resolution No. 5778 enacted by the Bellevue City Council on May 2, 1994 and pursuant to RCW 35.14.040, Resolution No. 5778 shall not become effective within the area of the East Bellevue Community Municipal Corporation.

<u>Section 2:</u> The East Bellevue Community Council disapproves Resolution No. 5778 for the following reasons:

- 1. Disapproval is based on the reasons enumerated in Section 2 of East Bellevue Community Council Resolution No. 353-A, which reasons are hereby incorporated by reference as if fully set forth herein.
- 2. This disapproval is consistent with the Community Council's disapproval of City of Bellevue Ordinance No. 4646, pursuant to Resolution No. 353-A.
- 3. The current Comprehensive Plan designation of Community Business reflects the understanding and intent of the citizens who developed the subarea plans, which were readopted as part of the Comprehensive Plan update in December, 1993. Resolution No. 5778 is inconsistent with such understanding and intent.

<u>Section 3:</u> The Clerk is hereby directed to certify the original of this Resolution, to file the same and to keep the same on file in her office. The Clerk is further directed to distribute certified or conformed copies of this Resolution to the Bellevue City Council, the Office of Policy Planning, and the Department of Community Development.
