

- ★ Fees for an Adult Family Home inspection with no construction are based on \$1,000 valuation.
- θ Charged when the scope of work requires Clearing & Grading or Land Use Review.
- Charged when the scope of work requires Clearing & Grading Inspections.
- \* Charged at issuance when the scope of work requires a Fire inspection.

Note: It is important to receive final inspection approval before your permit expires. If you do not, finals-only single family permits are: \$76 - Building; \$46 - Plumbing; \$53- Mechanical; \$72 - Electrical; \$69 - C&G
