A. Council Liaison Update

B. Bellevue School Board Liaison Update

Ms. Wiest provided the following report on Bellevue School Board activities:

- The BSB recently discussed their equity policy. Youth Link Boardmembers are encouraged to provide feedback on this policy.
- The BSD and PTSA are conducting education sessions on the increase in vaping in schools.

Ms. Wiest noted that each month the BSB visits a school. Last month, the Board visited Bellevue High School. This month, the Board will visit Phantom Lake Elementary School. The concept of "office hours" is being discussed where the BSB would be available for students to ask questions/provide comments. Boardmembers discussed the best day/time for these meetings. They also suggested that a prompt question be provided to create dialogue. Ms. Esparza also suggested that the BSB reach out to students participating in summer school.

6. TEAM BUILDING:

7. STUDY SESSION ITEMS:

A. The Changing Faces of Bellevue

Gwen Rousseau, Associate Planner/Demographer, discussed the latest information on Bellevue's demographics from the U.S. Census Bureau's 2017 American Community Survey. The Census assists with strategic planning, as well as determines political representation and distribution of funding for various resources.

Ms. Rousseau reviewed the guiding principles of the Bellevue Diversity Advantage Plan and discussed some of the drivers for the demographic changes. The changes in Bellevue from the 1950s to today were also discussed, including housing, demographics, school district information, etc. Some of the other topics discussed included:

- Cultural diversity
- Place of birth trends
- Age by race/ethnicity
- Top languages spoken
- Summary of trends

8. UNFINISHED AND NEW BUSINESS:

A. <u>Liaison Discussion</u>

Ms. Esparza explained that the BSB and Council liaisons would like to know what would be most helpful in their reports. Overall, the Board expressed interest in policies, particularly if they impact youth; how YL can specifically get involved; and provide any questions in advance to allow for productive input.

B. <u>Proposed Program Changes</u>

Ms. Esparza discussed some of the proposed program changes for the Youth Link Board, Youth Council, and Youth Link University. She noted that changes to the program would require changes to the bylaws. A draft of the proposed bylaws was distributed to Boardmembers.

Boardmembers requested that additional clarification be made to the "Selection" section of the bylaws as well as the number of meetings each month.

Motion by Boardmember Liu and second by Boardmember Amanda Li to approve the bylaws as presented with the clarification noted above. Motion carried unanimously (7-0).

After a brief discussion, Boardmembers realized that approval of any changes to the bylaws requires a two-thirds majority. Due to a lack of two-thirds majority, a separate vote will be cast to approve the changes to the bylaws.
