

Cougar Mountain/Lakemont

Thank you for participating in the Cougar Mountain/Lakemont Neighborhood Enhancement Program! In October, more than 650 households voted for three of 27 proposed enhancement projects to receive Neighborhood Enhancement Program (NEP) funds. A total of two projects will be funded with the \$306,000 Cougar Mountain/Lakemont NEP allocation, which will also encompass associated planning, design, labor and materials fees.



The following projects will be funded and implemented by the Neighborhood Enhancement Program over the following three to five years.

CL-21: Lakemont Boulevard SE Path \$246,000 429 points

Lakemont Boulevard SE, between the Lewis Creek Park Trailhead & SE 62nd Street

This project will remove existing brush and vegetation along the east side of Lakemont Boulevard SE, between the Lewis Creek Park Trailhead and SE 62nd Street, and create a stabilized, gravel shoulder for pedestrians.

CL-6: Wetland Buffer Enhancement \$50,000 246 points

Lewis Creek Park

This project will restore the degraded wetland buffer, east of the Lewis Creek Park Visitor Center, and adjacent to the walking trail. The restoration will include removing the existing, invasive vegetation and planting new, native plants.
