The following projects will be funded and implemented by the Neighborhood Enhancement Program over the following three to five years.

WLS-14 Northup Way Left Turn Lane
\$63,700 315 points

Northup Way at West Lake Sammamish Parkway

This project would extend the left turn lane on Northup Way, at West Lake Sammamish Parkway, by modifying the existing median and lane configuration. Construction of the project would begin after the water main replacement on West Lake Sammamish, scheduled for late 2017, and would not require closing the intersection.

WLS-13 West Lake Sammamish Parkway Flashing Crosswalk
\$105,000 301 points

West Lake Sammamish Parkway at The Little Store

This project would install a rapid rectangular flashing beacon (RRFB) crosswalk and additional streetlights on West Lake Sammamish Parkway, south of SE 26th Street, near The Little Store. This project would also incorporate vegetation trimming to ensure adequate sight distance requirements.
