If you've ever been curious about what happens behind the scenes at Bellevue Utilities to ensure the delivery of high-quality drinking water and safe disposal of wastewater, don't miss this chance to meet the people who make it all happen! The City of Bellevue's Neighborhood Outreach and Bellevue Utilities invite residents to attend the semi-annual Neighborhood Leadership Gathering on Thursday, Sept. 13, 6-8:30 p.m., at the Bellevue Service Center.

During the evening, participants will learn how the city keeps our storm drains clear and our lakes and streams healthy. They'll also hear how modern technologies are improving the delivery of utility services and the maintenance of aging pipes and drains. Bellevue Utilities Director Nav Otal will give a presentation called "Invisible Systems - Visible Benefits," providing an inside look at utilities operations and the value of water.

For the event, residents should dress warmly and wear comfortable shoes to participate in an exclusive tour of themed stations including recycling, capital programs, storm water education, and water, stormwater and wastewater operations. The evening includes a light dinner available at 5:30 p.m. and a chance to mix and mingle with Utilities staff.

The Neighborhood Leadership Gathering is a semi-annual gathering of neighborhood leaders who come together to share and learn from each other. 

## Good Neighboring Tips

### Kelly and the Wheelbarrow

Kelly needs a wheelbarrow to move some dirt in his yard. He decides to ask if he can borrow a wheelbarrow from his neighbor Bob.



As he steps out of his house to go to Bob's house, Kelly wonders if Bob is even home.

Walking out to the street toward Bob's house he thinks, "What if Bob is using it?"

Getting closer to Bob's house Kelly wonders, "What if Bob has loaned it to someone else?"

Stepping onto Bob's sidewalk, he almost exclaims out loud, "What if Bob just refuses to loan it to me but will loan it to everyone else?!"

Finally, he pounds on Bob's door. When Bob answers, Kelly shouts "I didn't want your \$#@\*\*!! wheelbarrow anyway!" and stomps off. Bob watches him leave, perplexed.

Like Kelly, we often invent stories and motivations for others based on our own fears, biases, and past experiences. When in conflict, we tend to build a case against the other built mostly upon assumptions.

We imagine they are purposely trying to irritate us, that their actions are aimed at us specifically, that they are lazy, thoughtless, mean-spirited, petty, rude. That they are doing something illegal. We read malicious intent into emails, texts and response times. Conspiracy theories abound!

In many cases, the actions of another person really have very little to do with us. It may be that our neighbors have their own stressors, that their own unusual set of circumstances make a puzzling choice seem perfectly logical, or that they have their own assumptions about us! It could be that cultural factors are adding to the confusion and misunderstanding.

When we are in a conflict with someone, it's time to get curious. "What do I know to be true? What am I guessing? How have I "horrible-ized" this other person? What am I projecting onto this other person that is really about my own fears and history?"

Next time we find ourselves at odds with a neighbor, perhaps we can give them the benefit of the doubt or lend a helping hand rather than a judging eye. We can treat them kindly, as we want to be treated.

## Telephone Conciliation Training

Are you a natural listener and a good communicator? Do you want to learn skills to help create peace in our community? Are you culturally sensitive? Do you possibly speak a second language? Do you live or work in Bellevue? Do you have time?

If so, you are encouraged to apply to become a conciliator with the Bellevue Conflict Resolution Center Program which helps people in the Bellevue community resolve their conflicts. Conciliators assist callers in understanding their issues, exploring options and developing strategies for problem resolution. In this training, you will learn conflict theory, advanced communication skills, negotiation, coaching, database usage and procedural tools. These skills are useful even if you don't volunteer.

There is no charge for the training. Attendance at all sessions is required. Upon completion, selected attendees are invited to volunteer in the mediation office for a three-hour weekly shift during business hours. Training and subsequent volunteering are steps to becoming a future certified mediator with our program.

## Electric vehicles take center stage at Sept. 11 event



If you're interested in learning more about electric vehicles, check out the National Drive Electric Week event on Tuesday, Sept. 11, 4-7 p.m., at the south end of Downtown Park, 10201 NE Fourth St.

More than 20 electric vehicles have been registered for the free event, representing 15 models by manufacturers such as Chevrolet, Ford, Fiat, Kia, Mitsubishi, Nissan, Tesla, Toyota and Volkswagen. Attendees may also:

- Take a test ride in an electric vehicle;
- Chat with owners about their experiences and the advantages of going electric;
- Ask questions of representatives from organizations such as Plug In America, Puget Sound Energy and Seattle Electric Vehicle Association; and
- Learn about the City of Bellevue's commitment to accelerating and integrating the adoption of zero emission vehicles.

For the second year in a row, the City of Bellevue is hosting the event, which is presented by Plug In America, the Sierra Club and Electric Auto Association, and sponsored by Nissan LEAF.

## New "Welcome to Bellevue" signs installed



As you drive into and out of Bellevue, watch for new picturesque "Welcome to Bellevue" signs in several areas bordering our city limit. In August, the following locations were the first to obtain new signs:

- Coal Creek Waterfalls near the Coal Creek Trail
- Village Park Drive near Lewis Creek Park
- 140th and 148th Avenue NE near the Bellevue Golf Course
- Lake Washington Boulevard - Bellevue Downtown Park
- West Lake Sammamish Parkway at NE 24th Street and west of I-90.

In 2019, more signs will be installed in the following neighborhoods: Bridle Trails, Newport Hills and Overlake. Past Bellevue signs have been removed over the past 10 years because either they were fading or worn out.

## New Lime Bikes Recently Rolled into Bellevue

Have you seen bright green bikes in your neighborhood or near work and wondered where they came from? The following should answer some of your basic questions:

**When did bike share come to Bellevue?** Bellevue launched a bike share pilot in July 2018. The green electric-assisted bikes are owned and operated by Lime, a private company that obtained a permit to use the public right-of-way— streets, sidewalks, and easements—to provide bike share services subject to specific conditions.



**What is bike share?** Bike share is a convenient, affordable, eco-friendly, and fun transportation option to get around Bellevue. Pick up a bike in one location and park it at your destination. You can find and unlock the nearest bike through Lime's mobile app. When you finish your ride, park your bike so that the bike is available for someone else to use.

**How long will the bike share pilot last?** The pilot permit is valid for up to one year—through July 31, 2019.

**Why is the City doing a bike share pilot?** The City of Bellevue wants people who live in, work in, and visit Bellevue to have more choices about how they get where they want to go. Bike share offers one more travel option that might be right for some people and some trips. Cities across the country have bike share systems, and local businesses and members of the public have been asking for bike share to come to Bellevue.

**How many bike share bicycles are allowed in Bellevue?** Lime is permitted to deploy 400 electric-assisted bicycles citywide in Bellevue in the first month of the pilot. After each month that they successfully demonstrate compliance with the City's requirements, Lime will be allowed to deploy 100 additional bikes.

**Why aren't other bike share companies operating in Bellevue?** Lime was the only company that applied for a permit to operate bike share in Bellevue in July 2018. Applications are no longer being accepted for the 2018-2019 pilot period.

**What if bikes from other companies end up in Bellevue?** Bike share bicycles from companies that do not have a permit will be declared a nuisance and must be removed from the City by the bike's owner within 24 hours of notice.

**Who do I call if a Lime bike is left on private property?** To address any issues with Lime bikes, please call Lime's number at 1 (888)-LIME-345, Text: 1 (888)-546-3345, or email [support@limebike.com](mailto:support@limebike.com).

**How much is this costing the City?** Bike share services in Bellevue are being provided by Lime, a private business. The City does not own or operate the system. To obtain a permit, Lime paid a fee that reimburses the City for various one-time and ongoing costs associated with managing the pilot, such as collecting and evaluating data, monitoring compliance, and installing preferred parking areas.

**What kind of data is being collected when I use bike share?** The Lime mobile app requires users to provide a phone number and the GPS units on each bicycle track where bikes are ridden. The Transportation Department requires Lime to share bike usage data to support permit oversight, performance evaluation, and inform infrastructure investment priorities. All trip data shared with the City is anonymous and passes through a third party—the University of Washington Transportation Data Collaborative—to ensure user privacy.

No personally identifying information is shared with the City or otherwise made public. More information about Lime's privacy policy is available on the company's website.

## More Work in the Roadway is slated for September

Fall is in the air and there is still time to complete several of transportation and utility improvement projects before the weather changes. In Downtown Bellevue, the following projects will be underway:



- 101st Avenue and Main Street All-way Stop Conversion – Stop signs will be installed this fall.

- 112th Avenue NE/108th Avenue NE between NE 12th Street and NE 24th Street – Construction of bike lanes and pedestrian facility improvements begin September/October.
- 124th Avenue NE between NE 8th Street to NE 12th Street - Interim bike lanes are being proposed for this section of 124th Avenue NE, depending on a survey to area residents.
- NE 12 Street Pedestrian Bridge – Bridge is currently closed to pedestrians while structural issues are analyzed, evaluated and tested for next steps.
- NE 8th Street between 132nd and 134th Avenues NE – The Utilities Department is closing NE 8th until Sunday, September 16. The culvert replacement project in Kelsey Creek will ensure the long-term safety of the roadway, protect critical utilities and improve fish passage.



In South Bellevue, the following projects will be underway:

- 2018 Pavement Overlay Project – Grinding & Paving work begins south of I-90.
- Mini-Roundabout designed for 164th Avenue SE and SE Newport Way – Project to address evening peak-time traffic conditions. Project information is being sent to the Eastgate area.
- 164th Avenue SE between SE 34th and SE 35th Streets – King County Wastewater continues to have a roadway closures to upgrade the Sunset/ Heathfield Pump Station & Force Main.
