# "When We Gather: Skills for Connecting as Listeners and Storytellers"

On October 31, The Cultural Conversations group will continue the theme of connection and the practice of creating the environment to enhance participants' experiences as both listeners and storytellers at their monthly gathering as well as in other parts of their lives. Cultural Conversations, a program entering its

seventh season, has transformed relationships and perspectives among diverse women in our community through education and storytelling since 2010.

Cultural Conversations offers an opportunity for rich storytelling and sharing between women from diverse backgrounds. The table conversations that take place hold great potential for deepening our understanding of others and for inspiring new friendships, but open sharing and meaningful connections aren't always a given. Last month, we learned that how we relate can be strongly influenced by culture and the deeper stories we carry. Being mindful of those influences, what are some additional ways as participants, might we strengthen our ability to foster connection when we gather?

### **Neighborhood Noise**

Saturday morning, around dawn. After a long, hard week, you're enjoying one of the great pleasures in life... sleeping in. Suddenly, a neighbor fires up his chain saw. Across the back fence someone starts banging nails. Your cherished slumbers are rudely terminated. For a while you vainly cover your head with the pillow, and then, discouraged and cranky, you get up to face the day.

Chronic noise problems often cause irritation and frustration. They can also be hard to resolve. Laws and ordinances protect us from some noise disturbances. But many people are reluctant to call the authorities on their neighbors. And some bothersome noises may be within legal limits — a fact that probably won't make the noise less disturbing.

Going to the authorities over a noise problem can be tricky. Your neighbors may see your action as hostile. Neighborly relations can deteriorate. Even worse, your neighbors might retaliate, for example by calling Code Compliance over that shed you constructed near the property line. Neighborhood feuds can rapidly snowball in this manner.

Another possible problem with going to the authorities is that the remedy they provide may not help you. For example, if you are a night owl who gets up around 10 AM, the standard "quiet time" provisions may not be the quiet time you need. Or, you may succeed in reducing the number of pets your neighbor can keep, only to learn that the neighbor is getting rid of their quiet cat, while keeping their three barking dogs.

An alternative to going to the authorities is to negotiate directly with your neighbor. We know this may not be easy – and we don't recommend trying this right after you've been woken up on Saturday morning. Nor should you wait through months and months of mounting frustration. However, if you prepare yourself and carefully pick the time to speak with your neighbor there is a good possibility that you can negotiate a solution that addresses your specific situation. Sometimes merely raising awareness can be helpful.

The Bellevue Neighborhood Mediation Program is here to help you open up productive discussions. We can coach you through it. The mediation program has highly trained telephone conciliators and mediators who can help facilitate the discussions between you and your neighbor. Mediation can be particularly helpful when the issues are emotional or complex. Through this process the conciliators will help you and your neighbor articulate your concerns in a safe, neutral environment, and then find a solution that works for everyone. If you want to explore enforcement options, it's important to know who to call. Here in Bellevue, it depends on the type of noise involved. Bellevue Code Compliance handles noise from a stationary source, such as a generator, heat pump, or compressor (425-452-4570). The City of Bellevue Noise Control Ordinance, Chapter 9.18, has numerous exceptions and special cases. The entire ordinance can be viewed on-line at <a href="https://development.bellevuewa.gov/">https://development.bellevuewa.gov/</a>. King County Animal Control handles barking dogs (206-296-7387). The Bellevue Police Department handles all other noise problems, such as loud parties (425-452-6917).

## City Exploring Options for **Bike Share Programs**

You may have heard that "free-floating" bike share services started operating in Seattle over the summer. In



recent weeks, some of those colorful bikes have made their way to the streets and sidewalks in downtown Bellevue. Against this backdrop, the city is exploring the public's interest in privately-run bike share services in Bellevue."We're committed to providing people a variety of travel options, and bike share could be part of the mix," said Transportation Director Dave Berg. "We support bicycling and value innovation, so we're looking at how private bike share operations might work here in Bellevue."An online survey is seeking the public's input about bicycling in downtown Bellevue, people's level of interest in seeing bike share come to Bellevue, and any concerns the city should consider. ### **East Link Construction**

Weekend closures of Bellevue Way continue for utility work: Bellevue Way will be reduced to one northbound lane for the weekends of Sept. 30-Oct. 1, Oct. 7-8, and Oct. 14-15. Typical closures will involve three lanes to be closed from 5:30 am Saturday through 9 pm on Sunday. Construction schedules are subject to change. Access to I-90 from Bellevue Way will be prohibited. The eastbound I-90 ramp to Bellevue Way will also be closed. Westbound I-90 to northbound Bellevue Way will be open.

#### Northern portion of 110 Ave. NE at NE 6 Street: Full lane closure begins early October:

In early October, Sound Transit's contractor will begin a long-term closure of a portion of 110 Avenue NE at NE 6 Street. The full closure (all lanes; all directions) is needed to build the East Link north tunnel portal near Bellevue City Hall. Closures on 110 Avenue NE will occur in three phases, lasting through spring 2019.

### **Other Construction Impact:**

**108 Ave SE: SE 21 Street to Bellevue Way:** Work begins in the area to improve pedestrian and bicycle facilities until the end of October. Traffic impacts may occur Monday through Friday, 8:30 am-3:30 pm.

Richards Road & Lake Hills Connector: Construction will begin at the intersection of Richards Road and SE 36 Street and continue north to the Lake Hills Connector. From there, it will continue west on Lake Hills Connector to SE 8 Street. Crews will remove and replace the sidewalk ramps at the corners of the intersections. New sidewalk ramps and audible-pedestrian-signal equipment are necessary to meet Americans with Disabilities Act requirements. Work hours on the site will vary by the work activity and the location. Work between SE 32 Street and SE 36 Street will occur at night. Lane closures between SE 32 Street and Lake Hill Boulevard will occur during the daytime, with the intent of avoiding commuter traffic when possible.
