## BACKGROUND

- Purpose of the Needs Update: "snapshot in time" of health and human services needs of Bellevue/East King County
- Used by Human Services Commission to make recommendations to the City Council for funding
- Other city departments, community members and organizations use report for planning
- Report has been published since 1988, every two years
- The report is a dynamic document, sensitive to what is happening in the external environment



### EXTERNAL ENVIRONMENT

- Still many cuts and uncertainty bring challenges
- Current State Legislative Session will bring more difficult choices with responding to the McCleary Decision and I 1351 (school class size initiative)
- Employment rate improving but there are still not enough living wage jobs
- Aging of the population continues to create more needs for support
- Transportation still shows up as a big barrier to accessing human services



#### EXAMPLES OF "DATA TO ACTION"

- Response to the "Great Recession": City Council provided additional funds for 2 years which were allocated for food banks, emergency financial assistance, shelter
- Response to implementation of the Affordable Care Act: continuing for the most part funding for health clinics serving those ineligible for the ACA as well as funding more low-cost dental services
- Response to increasing diversity: several new agencies were funded that serve the needs of Asian and Eastern European
