

#### **Bellevue Residents with Disabilities**






#### 15% of residents over 5 have disabilities: 15,487 people

Youth/Teens (5-20) 1,445

Adults (21-64) 9,218

Seniors (65+) 4,824

1970's City of Bellevue began providing adaptive recreation activities for individuals with disabilities

1980's Highland Community Center

1990's Adaptive programs at Highland and other City facilities


2000 Inclusion services in addition to adaptive programs

## **Progress**

- 2006 Choices Plan developed, goals met
- 2008 Choices Plan updated, new goals
- 2015 Diversity Advantage Plan
- 2015 ADA Coordinator hired
- 2016 Choices Plan update in progress

## Recreation for People with Disabilities Choices Plan

- Inclusion in general recreation, with or without accommodations
- Adaptive recreation as an additional choice for those who benefit
- Community expressed need for adaptive recreation



## Who is the plan for?

- Individuals with disabilities
- Parents/guardians of relatives with disabilities
- Community recreation providers
- Recreation professionals
- Elected officials, Boards and Commissions

## How was the plan developed?

- Information Gathering
  - User groups
  - Service providers
  - Best practices plans of other organizations
  - Legal requirements (specifically ADA requirements)

## **Adaptive Recreation**

- Builds skills needed to transition to an inclusive program
- Allows an individual to participate in an activity with others of similar ability
- Provides an introductory choice for learning new recreation activities

- Develops community support and encourages attitudinal changes to reflect the right of all people to dignity, self respect, and community involvement



#### **Diversity Advantage Initiative**

- Equity, access, inclusion and opportunity for all
- ADA compliance
- ◆ Title VI of Civil Rights Act
- Cultural competence
- Outreach & engagement



#### **ADA Self-Evaluation & Transition Plan**

- Draft complete: stakeholder review
- Council approval in mid-2016
- Evaluation of all city programs and facilities:
  - Requirements and self-evaluation
  - ID areas for further evaluation
  - Recommendations



#### **ADA Transition Plan**

- City Facilities (mostly Parks):
  - 16 detailed ADA assessment reports
  - Integrating ADA with CIP plans for Parks, Fire, Civic Services
  - Community input to prioritize access improvements
- Pedestrian Facilities:
  - Curb ramp and sidewalk data update
  - Accessible pedestrian signals
  - Better coordination with transit, most-used city facilities (parks, community centers, City Hall)



#### **Access to Bellevue Parks**



- Facility renovations for ADA compliance
- Community requests: nature trails, playgrounds, sport courts
- Access to all programs and services
- Provide accommodations or modifications as needed: golf carts, water chairs

## **ADA & Program Access**



- Hearing loops installed in City Hall and Bellevue Youth Theatre
- Captioning, ASL, Braille, large print
- Staff training
- City website redesign:
  - Improve accessibility
  - Multi-language web pages
- Community input:
  - Events, program priorities
  - Emergency planning
