1. **CALL TO ORDER:**

The meeting was called to order by Chair Van Hollebeke at 5:30 p.m.

2. <u>COUNCIL PRIORITIES AND/OR STAFF WORK PLAN:</u>

Chair Van Hollebeke provided an overview of the retreat agenda. He discussed the importance of moving the city's vision forward as a City in a Park. Some barriers to accomplishing this vision include economic growth and funding gaps. Chair Van Hollebeke stressed the importance of aligning the Parks Board's priorities with the Council's priorities.

Councilmember Robertson provided highlights from the January, 2018 Council Retreat. A list of priorities that were identified at the retreat is being finalized. Council also revised the city's vision. Some of the priorities identified at the retreat that impact parks include:

- Grand Connection
- Bel-Red Lookback
- Aquatic Center
- Update of Parks & Open Spaces Plan, specifically service levels

Councilmember Robertson discussed the shift across the region regarding citizens' hesitation for additional taxes/levies.

Councilmember Robertson clarified that once the Council priorities have been formally adopted, they will be forwarded to the various Boards/Commissions. Then, staff will develop a process for the Boards/Commissions to work on the priorities. If a Board/Commission would like to deviate from the Council's priorities, then this should be communicated to Council.

Boardmember Heath is encouraged to hear that Council is interested in working with the Board in a meaningful way. He requested that a plan with timelines be created so the Board knows what needs to happen, including when communications need to be submitted to Council for the Parks Board to be heard. Boardmember Heath discussed his frustration from the last budget process where the Parks Board did not feel heard.

Chair Van Hollebeke suggested that Boardmembers prepare a memo to Council regarding the 2019-2025 Capital Investment Program (CIP) Plan and then shortly after, forward a memo regarding the Parks Board's visions and the continued funding gaps.

Boardmember Kumar asked if park impact fees have been considered by Council. Councilmember Robertson responded that the Planning Commission recommended park impact fees. However, she is uncertain as to the current status of the fee consideration. She encouraged Boardmembers to think aspirational but also consider the mood of the community. Other priorities that are important to Council include: multicultural center, aquatic center, Grand Connection. Councilmember Robertson noted that if the Parks Board priorities are aligned with a Councilmember's priorities it would be advantageous.

Chair Van Hollebeke suggested that the Board's CIP memo to Council include an increase in the budget allocation for parks.

3. **BUDGET/CIP:**

Mr. Sanner provided an overview of the 2019-2025 Parks Capital Investment Program budget process. He reminded Boardmembers that the budget is a two-year Operating Budget and seven-year CIP. The following items were distributed to Boardmembers:

- Parks 2019-2025 CIP Budget Proposals
- Unfunded Parks Capital Project List
- Preliminary 2017-2023 Parks Capital Investment Program memo (dated November 8, 2016)

Overall, the total additional funding request is estimated to be \$53.7M with \$22M additional funding needed beyond the estimated revenue available.

Councilmember Robertson suggested that certain projects be grouped together (i.e., work on design first and then obtain grants for additional work). This might help project move through the process more quickly.

Boardmembers reviewed the list of New/Additional Projects that were included on the Parks 2019-2023 CIP Budget Proposal. These projects included:

- Airfield Park Development (Levy project)
- Meydenbauer Phase II Construction (Gateway project)
- Newport Hills/Tyler Development
- Bridle Trails/140th Development
- Ashwood Design & Permitting
- Lake Sammamish Planning & Design

Mr. Foran discussed the phasing that can be done on some of the projects (i.e., conduct planning and design during one budget cycle, and then development in a different budget cycle).

Boardmembers would like their support of Meydenbauer Phase II Construction and an aquatic center noted in the CIP memo to Council. They would also like to request that the Parks funding cuts made during the market downturn be restored. Boardmembers also reiterated their support to fulfill the commitment to voters on the levy projects.

Boardmember Trescases suggested that the geographic equity of Bellevue be evaluated to ensure that all quadrants of Bellevue are being served.

Vice-Chair Synn inquired if there is special consideration that needs to be given to REI. Mr. Foran clarified that REI has designed a site that mimics their values system. REI has been working on sponsorships and employee volunteer interests. No special consideration needs to be given to REI at this time.

Motion by Boardmember Kumar and second by Boardmember Trescases to approve the Parks 2019-2025 Capital Investment Program Budget Proposals list with the following edits:

- Remove Ashwood Design & Permitting (included in other funding source)
- Remove Lake Sammamish Planning & Design (included in other funding source)

At the question, motion carried unanimously (7-0) to approve the Parks 2019-2025 Capital Investment Program Budget Proposals list as edited.

Break—7:50-8:05 p.m.

4. **BYLAWS:**

Vice-Chair Synn summarize the meeting that he and Boardmember Heath had with city staff to review the proposed Bylaws. Areas of concern include:

- Definition of Bylaws
- Hierarchy of documents

Vice-Chair Synn also suggested that Article VI.A be altered to reflect current procedures. Item A notes that "Preparation of meeting agendas will be the duty of the Board staff in coordination

with the Chair." However, Vice-Chair Synn explained that the current practice includes agendas being set at Board meetings with Board input.

Councilmember Robertson explained that the City adopted Chapters in the Code in regards to each Board/Commission. The Parks Board is referred to under Chapter 3.62 and the Bylaws are established in Section 3.62.050. Boardmembers appreciated this clarification and noted that the Code should be referenced in the Bylaws.

Boardmember Trescases suggested that Article VI.A be maintained as is, since it is a broad statement and includes the current process and other variations of the process. She feels that if the process description is finite, there won't be flexibility when setting agendas.

Boardmembers concluded that the following changes should be made to the proposed Bylaws:

- Add a reference to Chapter 3.62 in Article 1
- Change Article VI, Item A to read: "Preparation of meeting agendas will be the duty of the Board staff, in coordination with the Chair, taking into account the input, if any, from the Parks Board at previous meetings."

Any further suggested edits should be forwarded to staff. A revised version of the Bylaws will be presented at the next Board meeting for approval.

5. **NEXT STEPS:**

Chair Van Hollebeke summarized the next steps for the Board:

- Review/approve Bylaws (May meeting)
- Review/approve CIP Memo to Council (June meeting)
- Outreach to Council to reiterate Board priorities (Summer)
- Long-term Memo to Council (Fall)

6. **ADJOURNMENT:**

Motion by Vice-Chair Synn and second by Boardmember Kumar to adjourn the meeting at 8:44 p.m. Motion carried unanimously (6-0).

1. **CALL TO ORDER:**

The meeting was called to order by Chair Van Hollebeke at 6:05 p.m.

2. **APPROVAL OF AGENDA:**

Motion by Boardmember Kumar and second by Vice-Chair Synn to approve the meeting agenda as presented. Motion carried unanimously (6-0).

3. **APPROVAL OF MINUTES:**

Motion by Vice-Chair Synn and second by Boardmember Kumar to approve the March 13, 2018 meeting minutes as presented. Motion carried unanimously (6-0).

4. ORAL COMMUNICATIONS/PUBLIC COMMENTS:

Mr. Parker called attention to an email that was submitted from Chris Johnson regarding "Bellevue Parks CIP Proposal." The email requested that a park bench be placed at Bannerwood Park. Mr. Parker noted that staff is working to implement the park bench idea in the near future.

5. <u>COMMUNICATIONS FROM CITY COUNCIL, COMMUNITY COUNCIL,</u> BOARDS AND COMMISSIONS:

Councilmember Robertson reported that Council recently approved their list of 3-year priorities and a vision. A list of priorities was distributed to Boardmembers. Councilmember Robertson called attention to some of the priorities that impact Parks.

There was a general discussion regarding how the Parks Board wants to relay their list of CIP priorities to Council. Councilmember Robertson noted that a Parks Board representative has not made a formal presentation to Council in quite some time so an appearance at a Council meeting would be welcomed. She also suggested that Boardmembers consider adding a memo to the Council packet that includes the Parks Board's list of capital priorities.

Boardmember Trescases suggested that the "Proposed 2019-2025 Parks Capital Investment Program" memo be sent to Council as written. Then, a separate memo could be sent to address the funding gap for Parks.

Vice-Chair Synn inquired if Council priority #19 ("Continue to implement the Diversity Plan, including the availability of and need for multi-cultural programming in the City.") falls under the community service role of the Board. Councilmember Robertson clarified that the previous priority addressed developing the Diversity Plan. Since the Plan has been developed, the priority was altered to include implementing the Plan. Mr. Foran noted that since the Plan is complete and is in the implementation phase, oversight of the actual work is under the direction of the City Manager's Office. However, the Parks Board may be asked to assist with implementation.

Boardmember Heath inquired if the Parks Board Ordinance references the Diversity Plan. Mr. Parker clarified that the Diversity Plan is not specifically referenced in the Parks Board Ordinance. However, diversity programming was housed in the Parks Department for quite some time. Now that the program is in the implementation phase, ownership has moved to the City Manager's Office so it is cross-departmental. Councilmember Robertson noted that the City Code, Chapter 3.62.070 notes that "The Board shall act in a policy advisory capacity to the City Council." She added that Chapter 3.62.070, Item G specifies "cultural diversity" as well.

Vice-Chair Synn requested clarification for the next steps in regards to Cultural Diversity. Councilmember Robertson responded that staff will inform the Parks Board when their input/work is necessary. However, cultural diversity should be considered when conducting any work within the Parks Board scope.

Vice-Chair Synn inquired if "A City in a Park" is the current brand identity referenced in Council priority #25 ("Develop and establish a new brand identity for the City of Bellevue that reflects both our past and our future, an identity that is iconic and leaves a lasting impression that Bellevue is a place that people want to live, work, learn and play."). Councilmember Robertson explained that Council wants to review the current brand to see if it encapsulates the current vision and where Council sees the City going in the next 20+ years.

6. **DIRECTOR'S REPORT:**

On behalf of the Board, Mr. Foran presented Chair Van Hollebeke with a plaque and framed picture as a token of appreciation. In addition, Boardmembers and staff expressed their appreciation to Chair Van Hollebeke for his valuable contributions to the City and Board.

Councilmember Robertson read a Commendation for Chair Van Hollebeke to thank him for serving on the Parks Board.

7. **BOARD COMMUNICATION:**

Chair Van Hollebeke enjoyed sharing Downtown Park with an out-of-town colleague.

Boardmember Kumar attended the Bellevue Neighborhood Conference and visited various parks throughout Bellevue.

Boardmember Trescases recently visited Crossroads Park and noticed a new park bench in the park. She thought that this is a wonderful way for community members to honor their loved ones.

Boardmember Hamilton attended the Bellevue Neighborhood Conference. He also visited Enatai Beach Park. Boardmember Hamilton has been staying connected with the Parks Department via social media. He suggested that an educational presentation be made at a future Board meeting to provide an overview of Parks social media resources.

8. CHAIR COMMUNICATION & DISCUSSION:

Chair Van Hollebeke expressed his appreciation to fellow Boardmembers and staff for their continued support. He has enjoyed his time spent on the Parks Board.

9. **BOARDMEMBER/COMMITTEE/LIAISON REPORTS:**

A. Wilburton Citizen Advisory Committee

Boardmember Kumar reported that the Wilburton Citizen Advisory Committee concluded their work in April, 2018. Boardmembers expressed their appreciation to Boardmember Kumar for serving on the Wilburton CAC.

10. <u>DISCUSSION/ACTION ITEMS</u>:

A. 2019-2025 Parks CIP Budget

Mr. Sanner reviewed the "Proposed 2019-2025 Parks Capital Investment Program memo" to be submitted to Mayor Chelminiak and City Councilmembers.

Chair Van Hollebeke suggested that verbiage from the list of Council 3-Year Priorities be incorporated in the proposed memo. Boardmembers agreed with this recommendation and expressed their support of the overall message of the memo.

Motion by Boardmember Trescases and seconded by Boardmember Kumar to conceptually approve the Proposed 2019-2025 Parks Capital Investment Program memo. Staff will incorporate additional language into the memo that aligns with Council priorities. The final version of the memo will be reviewed and approved by Chair Van Hollebeke and Vice-Chair Synn, and then forwarded to Council. Motion carried unanimously (6-0).

B. Park Board Bylaws

Vice-Chair Synn discussed the following changes that were made to the proposed Bylaws, since the Board Retreat:

- Article 1 add the specific Bellevue City Code reference.
- Article VI.A. revise wording related to Chair, Vice-Chair and staff preparing the meeting agenda with input from the Board.
- Article V.A. deleted the words "or both" in the phrase related to the months in which the Board may recess. This edit was requested by the City Clerk's Office in order to align with existing adopted City Code stating that the Board may recess for the month of August or December.
- Article VI.D. this draft updates the order of business on the agenda to align with current practice.

Vice-Chair Synn noted that additional edits were due the week after the Board Retreat. However, none were received.

Boardmember Heath recommended that Article VI.A. be changed to read: "Preparation of meeting agendas will be the duty of the Board staff pursuant to the direction of the Chair and Vice-Chair, taking into account the input, if any, of the Board at previous meetings." Boardmember Heath thinks the change helps clarify authority for the agenda-making process.

On the contrary, Boardmember Trescases expressed her support of the Bylaws, as written. In particular, she views Article VI.A. as written to provide flexibility, if needed, since staff plays a key role in meeting agenda and content preparation. Chair Van Hollebeke agreed with Boardmember Trescases noting that there are other areas of the Bylaws that note the agenda is set by the Board in conjunction with staff. He added that the process is a collaborative exercise where no one party mandates the process.

Boardmember Heath reiterated his disagreement with Article VI.A.

Councilmember Robertson stressed the importance of staff's involvement with setting meeting agendas because Council may provide direction that staff needs to include on a meeting agenda. In addition, she called attention to the Parks Board Ordinance, Chapter 3.62.060, which states: "The Parks & Community Services Department shall provide technical and administrative support for the Board," and 3.62.080.B, which limits the Board's powers and duties when it comes to supervision of staff.

Chair Van Hollebeke views the current process for setting meeting agendas as extremely collaborative. At times, staff has knowledge of agenda items that are discussed at the Board premeeting. Staff also captures any agenda topics that are raised during Board meetings.

Vice-Chair Synn noted that Article VI.E. allows the Parks Board to change the meeting agenda, if needed. ("The printed agenda of a regular meeting may be modified, supplemented or revised by a majority affirmative vote of the Boardmembers present.")

Motion by Vice-Chair Synn and second by Boardmember Trescases to approve the Parks & Community Services Bylaws as presented.

Boardmember Heath expressed his strong disapproval of the proposed Bylaws. He views Article VI.A. as a step back in the process where staff sets meeting agendas. He reminded Boardmembers of a situation in 2014 where Boardmembers identified specific priorities, yet these were never placed on a meeting agenda. Boardmember Heath also cited an example of a Planning Commission meeting that he attended where the Parks Board should have been informed about a particular issue but was not. He discussed another situation that happened with the City Clerk; not to mention the frustration regarding the Bylaws process. Boardmember Heath again expressed that he does not support the proposed Bylaws.

At the question, motion carried (6-1) to approve the Parks & Community Services Bylaws as presented.

Subject: Annual Election of Chair and Vice-Chair

(Board action requested)

At the June meeting, the Board will elect a Chair and Vice-Chair to serve the next twelve-month term. Since former Chair Van Hollebeke's service on the Board ended on May 31, 2018, Vice-Chair Synn will preside at the June 12th meeting. He will facilitate the election process and continue to run the remainder of the meeting.

Chair and Vice-Chair elections follow direction from Bellevue City Code 3.62.020 regarding membership, appointment, and terms for the Parks & Community Services Board:

A chair, vice-chair and such other officers as the board deems necessary shall be elected annually from its members. The chair shall preside at meetings; the vice-chair shall preside at meetings in the absence of the chair.

The Parks & Community Services Board's Bylaws (Article II.B) state:

<u>Election of Officers</u>. The Board shall elect a Chair and Vice-Chair, and any other officers the Board deems necessary, for a term of one year at their first regular meeting in June of each year, or as soon thereafter as feasible based on seating of newly-appointed members. The election process shall be in accordance with *Robert's Rules of Order Newly Revised*.

You are free to nominate and elect the Chair and Vice-Chair officers at your discretion. Also, as always, the Board Chair (or in this case, the Vice-Chair) votes along with other Boardmembers. Remember that a Boardmember cannot abstain from voting; a failure to vote will be counted in the affirmative (BCC 3.62.030.D).

Please see the following page for a more detailed explanation of the nominating/voting process.

Board Election Process

(Summarized from Robert's Rules of Order)

Nominations for Chair

- Chair calls for nominations by saying, "Nominations are now in order for the office of Parks & Community Services Board Chairperson."
- Any Boardmember can nominate another Boardmember.
- A "second" to the nomination may occur but is not required.
- The nominated Boardmember may decline or accept the nomination.
- Nominations continue until all Boardmembers who wish to nominate have done so.
- Chair closes nominations by asking, "Are there any further nominations for Parks & Community Services Board Chairperson?" (pause) "If not, nominations are closed."

Voting

- Chair explains the method of voting by hands, or by aye/nay.
- Candidates are voted on in order of nomination.
- Chair begins the voting process by saying, "Those in favor of _____ for Board Chair, raise your hand up high." And then "Those opposed, raise your hand high."
- If the majority votes for the initial candidate, the Chair declares that person elected. If the majority votes no, the Chair declares that candidate not elected and moves on to the next nominee.

Repeat the process for Vice-Chairperson.

IF YOU ABSTAIN FROM VOTING - YOUR VOTE COUNTS AS "YES":

Affirmative votes from a majority of members present and voting shall be necessary to carry any proposition, including elections. A member who fails to vote without a valid disqualification is declared to have voted in the affirmative

IN CASE OF A TIE:

If voting proceeds through all of the nominees and NONE of the nominees receives a majority vote, the Chair may call a short recess before reopening nominations to take any additional nominations. Reopening nominations requires a motion. If no additional nominations are forthcoming, the Chair will call for a revote on the original nominees. If additional nominations are made, they are added to the existing list of nominees.

When repeated balloting is necessary, the names of all nominees are kept on the ballot in the order in which they were originally presented.

Subject: Grand Connection Interstate 405 Crossing

(Board feedback requested)

ACTION REQUESTED

The Parks & Community Services Board will be provided an update on the process to select a preferred crossing over Interstate 405 for the Grand Connection.

The Parks & Community Services Board will be asked to provide their feedback and input regarding the project.

BACKGROUND

The Wilburton-Grand Connection planning initiative was launched on December 7th, 2015 as a Council priority. The project includes two primary elements, a re-visioning of the Wilburton Commercial Area and the visioning of the Grand Connection

Grand Connection - Framework Plan Volume 2

In December of 2017 Council adopted the *Grand Connection Framework Plan Volume 1*, addressing the route's identity, aesthetics, public space improvements, and improvements to mobility and connectivity between Meydenbauer Bay and the Civic Center District. Adoption of the plan initiated the process to amend the Comprehensive Plan, update the Land Use Code, and develop Design Guidelines. In May of 2018, staff presented Volume 2 of the framework plan which provided an in depth assessment of the three Interstate 405 crossing alternatives.

The plan discusses important elements of each of the crossing alternatives, including a comparative analysis and next steps to selecting and refining a preferred alternative. Staff will be presenting the report to various interest groups during the summer and will return to Council in July to seek direction on a preferred crossing alternative.

Tonight, staff will provide the Board with a brief update on the timeline and process to select a preferred crossing alternative. Staff last presented the alternatives to the Board on July 7, 2017. The second volume of the plan can be found at:

Aquatic Center Study

At their March 12 meeting, the City Council authorized the staff to proceed with additional studies to determine whether Council wishes to proceed with an Aquatic Center. We will explore the potential scale and scope of a facility, estimated capital and operating costs, prepare a site feasibility analysis, public outreach and potential partnerships. The initial feasibility study done in 2009 will be updated. We are currently soliciting consulting teams to work on this project, and expect work to begin later this summer.

Bannerwood Park

The staff is working with representatives of Seattle University to provide additional upgrades to the Bannerwood baseball facility. SU would like to install a roof over the existing batting cages and to construct a small multi-use/clubhouse building behind one of the dugouts, all at the cost of SU. We are currently working to amend our current agreements with SU to facilitate these improvements.

2019-25 CIP Budget

Budget proposals for the 2019-25 CIP budget have been forwarded to the Leadership Team, who expect to deliver a recommendation to the City Manager later this summer. Our requests include continued funding for the Renovation Program, Park & Open Space Acquisition, and Park Planning; neighborhood park development in Bridle Trails and Newport Hills; construction at Airfield Park; planning future phases of Meydenbauer Bay; supplement funding for the Northeast Corner of Downtown Park; and initial funding for Bel-Red parks and streams.

Downtown Park – NE Entry

An artist contract has yet to be executed, which continues to delay design work. Initial concept plans were prepared and shared with the Park Board in February and reviewed by internal staff in May. We met with neighboring businesses and internal staff to discuss the feasibility of eliminating the existing alleyway through the NE corner parcel, and are preparing follow up meetings to review proposals. Once the artist is on-board and concept plans have been refined to reflect artist proposals, we will return to the Park Board for further review.

Meydenbauer Bay Phase 1 Park Development

Construction is approximately 70% complete, with expected completion at the end of 2018. The beach house structure is complete and interior work is underway. Stream bed construction and pedestrian overlook structures are complete. Most in-water work is complete, including shoreline restoration, piling installation and the pier structure. The floating pier sections will be installed this summer. Most concrete retaining walls are now complete, and the granite boulder retaining wall and terrace work is now underway. The overhead wires along LWB have been buried and street lights are installed. Sidewalks along 99th Ave. and LWB are expected to be constructed in June. Utility work along 99th Street is underway, and a series of retaining walls at the end of 99th to provide access to the water and hand-carry boat launch is nearing completion. The Whaling Building remodeling is out to bid and expected to begin after Labor Day.

We continue to coordinate park work, construction access and utility infrastructure with Sound Transit. The park was closed to the public in April and rough grading throughout the park is close to completion. Underground infrastructure to support irrigation, power and stormwater systems is underway. Some planting/restoration work may continue next spring depending on weather and light rail construction. Staff continues to work with the adjacent neighbors to address property encroachment issues and to identify an appropriate boundary fence to install. The City Attorney's office is working on the next communication with the neighbors.

FAQs: Boards and Commissions Training

Q: Why is this training being offered?

A: In 2014, Council approved the Bellevue Diversity Initiative: The Diversity Advantage and the vision statement, Bellevue welcomes the world. Diversity is our strength. This Initiative resulted in 60 recommendations, which were gleaned from various listening sessions with our City staff and community stakeholders, and categorized under the following focus areas: Cultural Competence in City Government, Cultural Competence in the Community, Human Services, Public Safety, Education, Economic Development, and Civic Engagement. Under Cultural Competence in City Government-5, "Provide cultural competence training for City volunteers and community leaders, including those serving in City boards, commissions and advisory committees."

The general goals of the training are:

- 1. Build community & deepen our understanding of cultural competence and equity
- 2. Increase our self-awareness, exploration of cultural differences, and understanding of systemic inequity
- 3. Practice applying cultural competence in our daily work
- 4. Commit to transferring learning beyond the session

Q: What is Cultural Competence?

A: The City of Bellevue defines cultural competence as the ability to "produce equitable policies and practices by developing skills that facilitate effective interactions across diverse cultures" (Diversity Guiding Principles). The City of Bellevue is using cultural competence as the guiding principle to drive the work of the Diversity Advantage Plan.

Q: Who else is doing or has done the training?

A: Under the recommendation, "provide systemic and regular cultural competence training for all city staff over a 5-year period," of the Diversity Advantage plan, several of City teams including department directors, member of the Operations Policy team, Diversity Advantage and Diversity Liaisons, have taken a 9-hour course. To date, the city has trained a little over half its workforce in cultural competence foundations. This training was also offered to Council, board members, and commissioners in 2015.

Q: Will there be pre-work?

A: You will need to fill out a survey prior to the training. Individual survey responses are done anonymously and are meant to illustrate the general knowledge-base of the group regarding cultural competence. You will receive a link once we've established which training date you will be attending.

Q: Am I required to attend?

A: No, you are not required to attend, although we highly recommend and hope that you attend one of the two training offerings.

Q: When are the training dates and how can I sign up?

A: Training dates are for June 20 and June 28 from 5-9pm. A light dinner will be provided. You may sign up for one of these dates through your staff liaison with a copy to Elaine Acacio (eacacio@bellevuewa.gov). Trainings will be at City Hall in room 1E-108.

Q: What happens after the training?

We hope the training will enhance awareness and skills in cultural competence and as a result, will prompt conversations about the ways in which we are informed, how we make decisions, and who we include in making such decisions. We also hope that these skills and conversations will aid in enhancing efforts equitable and fair processes to better serve the growing and diverse communities in Bellevue.

Subject: World Elder Abuse Awareness Day Proclamation

To bring attention to misconduct perpetrated against older adults, groups around the world are proclaiming June 15, 2018 as the thirteenth Annual World Elder Abuse Awareness Day. This day is set aside in support of the International Network for the Prevention of Elder Abuse (INPEA). Due to the timing of this international recognition and the Council meeting schedule, we are choosing this evening to recognize the importance of World Elder Abuse Awareness Day by presenting this proclamation.

The main goal of this proclamation is to increase Bellevue society's ability, in accord with international collaboration, to recognize and respond to the mistreatment of older adults in whatever settings it occurs, so that each individual can achieve an optimal quality of life in keeping with his or her cultural values and traditions.

"Elder abuse" describes a range of offenses. The signs of abuse are sometimes hard to distinguish. In most cases, elder abuse is perpetrated by a known, trusted person, usually a family member. Neglect and self-neglect are the most common types of abuse, although emotional abuse and financial exploitation are common, too. Startling examples can be found all around us, including cases in Bellevue.

As community members, family, and friends, we all need to be vigilant. To identify mistreatment, experts recommend looking for clues like unexplained physical injuries or repeated accidents. Changes in behavior such as crying, isolation, deteriorating health, and hygiene sometimes point to mistreatment. Financial troubles that appear out of the blue can send up red flags signaling possible exploitation. Dilapidated homes with rodent infestations may indicate neglect or self-neglect.

If you suspect an older or disabled adult is being abused, neglected, or exploited, immediately call the State protective service hotline at 1-866-END-HARM (1-866-363-4276). Police also recommend calling 911 to request that the Police perform a "Welfare Check".

Also, we invite Council, staff, volunteers, and all members of the community to join us in raising awareness and educating our Bellevue residents about Elder Abuse.
