What is the Needs Update?

- Compilation of quantitative and qualitative data from a wide variety of sources
- Analysis of health and human services trends and issues that affect the quality of life of Bellevue residents
- Forecasting of "most likely future": how can the City best prepare for changes in human services in a quickly changing environment?

Purpose of the Needs Update

- Guide the recommendations for allocation of 2021-2022 Human Services Fund/Community Development Block Grant by the Human Services Commission to the City Council
- Direct the work of Human Services Division staff
- Provide information for other City departments, community groups, faith communities, agencies and regional planning efforts



- Review of reports, websites, American Community Survey and Census data

Top Themes from the 2017-18 Human Services Needs Update

Affordable Housing

- In 2017 77% of phone and online survey respondents rate lack of affordable housing as the number one community problem compared to 68% in 2015.
- Almost one in three (31%) of Bellevue renters are cost burdened and one in six (16%) are severely cost burdened. This results in households unable to meet their basic needs such as food and transportation.
- Over 9,100 Bellevue households have low and very low income. However, there are only 3,095 units of affordable housing in Bellevue





Lack of affordable housing is consistently the top-rated problem area in the community, and 2017 saw a 9 percentage point jump to the highest level in more than 10 years.

Increase in Homelessness

- During winter 2016-17, the Eastside winter shelters served the following:
 - Men's Shelter: 429 men
 - Women's Shelter: 192 women
 - Families Shelter: 137 adults and 182 children
- Bellevue School District reports the number of homeless students has steadily increased from 48 in 2006-07 to 257 in 2016-17.

BSD Students Receiving McKinney-Vento Services by School Year, 2006-07 to 2016-17





Mental Health and Substance Use Disorder

- In 2016, 15% of 8th graders, 17% of 10th graders, and 16% 12th graders in the Bellevue School District said they contemplated suicide. (Source: Healthy Youth Survey)
- In 2016, there were 332 drug-caused deaths in King County and 219 of them were from heroin and prescription opioid overdose.
- 30% of phone/online survey respondents rated mental illness or emotional problems as a major/moderate community problem in 2017. Of the respondents who indicated that they or someone in their house had sought help, 92% could not find help for mental health counseling.

Racial and Ethnic Inclusion

- In the 2017 phone/online survey, 24% of respondents rated in racial and ethnic discrimination as a major or moderate problem in their community, a significant increase from 17% in 2015.
- In seven months, Eastside Legal Assistance Program met with over 1,000 East King County residents on immigration issues.
- 42% of Bellevue residents spoke a language other than English at home.

Transportation

- In the 2017 provider's survey, 70% of respondents reported that their clients needed, but couldn't find, help with transportation.
- In the phone/online survey, 39% of respondents rated inadequate public transportation as a major or moderate problem in their community.
- About 8% of Bellevue residents over 65 state they do not have a vehicle. Making the decision to stop driving either for health or financial reasons can have an impact their ability to meet their basic needs, such as doctor visits, shopping, and recreation.

- Draft report to the Human Services Commission in November 2019
- Presentation of findings to the Council in January
 2020
- Distribution in February 2020
