

# Construction Alert

## Northeast Bellevue Crosswalk Improvements



June 2019

### Description and benefits

The Bellevue Transportation Department will make the following pedestrian safety improvements at five existing crosswalks and construct one new crosswalk in Northeast Bellevue.


- **NE 24th Street at 166th Avenue NE:** Install flashing beacons, relocate eastbound and westbound bus stops closer to crosswalk, construct new bus pads and extend existing sidewalks to the bus stop.
- **164th Ave NE south of NE 24th Street:** Install flashing beacons, rebuild existing median island, upgrade sidewalk and curb ramp and repave the affected roadway.
- **Northup Way at 160th Avenue NE:** Install flashing beacons at the existing crosswalk.
- **Northup Way at 166th Place NE:** Install flashing beacons, construct new sidewalk at the southeast and southwest corners and repave the affected roadway.
- **Northup Way at 168th Avenue NE:** Install flashing beacons, relocate bus stop closer to crosswalk, build new bus pad and extend existing sidewalk.
- **Northup Way at NE 10th Street:** Install flashing beacons at crosswalk and speed feedback signs.

### What to expect and when

Construction is anticipated to begin in early July and be completed by fall 2019. Approved work hours are Monday



through Friday, 8:30 a.m. to 3:30 p.m. Expect single lane closures during construction and anticipate some delays.



### For your safety

Thank you for your patience during construction and for doing your part to be safe near the work zone.

### Funding

Construction funding comes from the city's Neighborhood Safety, Connectivity and Congestion Levy and Minor Capital Traffic Operations programs as well as the Washington State Department of Transportation Pedestrian-Bicycle and the Federal Highway Administration Safe Routes to School grant programs. Estimated cost is \$1.5 million.
