



#### PROJECT DESCRIPTION:

THE PROPOSED PROJECT IS 8,150 SF ADDITION TO THE EXISTING STONE GARDENS ROCK CLIMBING CENTER. THE NEW ADDITION WILL CONSIST OF A NEW LOCKERS ROOM, NEW RESTROOMS, A MEZZANINE FOR VIEWING AND CLIMBING WALLS. 29 EXISTING PARKING STALLS WILL BE REMOVED. THE REQUIRED PARKING WILL BE MET THROUGH THE CROSSROADS MALL SHARED PARKING AGREEMENT.

THE DEVELOPMENT SITE ABUTS THE CROSSROADS PARK TO THE EAST AND RETAIL PARKING TO THE WEST, SOUTH AND NORTH.

THIS ADDITION IS PHASE I OF 2 PARTS. THERE ARE PLANS TO DEVELOP THE SOUTH PARKING SURFACE LOT INTO A PUBLIC PLAZA AND A MIX USED BUILDING (SEE BELLEVUE PERMIT 17-125964-DB).






