



Work notice: Nighttime construction work on I-405 in Bellevue begins Nov. 2

Three weeks of pavement grinding on I-405 between Woodridge and downtown Bellevue

PROJECT DESCRIPTION

Contractor crews working for the Washington State Department of Transportation will be grinding highway concrete pavement along I-405 between the Woodridge neighborhood and NE 2nd Street in downtown Bellevue.

This is part of the I-405 Renton to Bellevue Widening and Express Toll Lanes Project, which is scheduled to be complete in 2024.

Flatiron-Lane Joint Venture is the contractor selected by WSDOT to build this project. The project will reduce congestion and improve safety along I-405 by adding highway capacity and making other safety and mobility improvements between Renton and Bellevue.

DESCRIPTION OF NIGHTTIME WORK

Crews will be grinding the highway concrete pavement to improve friction on the roadway surface. This work involves lane and ramp closures and must be performed at night to avoid impacts to daytime traffic.

Work hours will be Monday – Thursday nights, 9 p.m. – 5 a.m. The work is weather dependent, and will begin as soon as Monday, November 2 and take up to four weeks to conclude. The work is being performed under a temporary noise variance issued by the City of Bellevue.

The equipment involved will include crew trucks, tanker trailers, grinders, and equipment to apply and dry lane line striping.

Crews will use strategies to minimize noise and disruption while working at night, including:

1. Avoid banging truck tailgates.
2. All trucks hauling material will have well-maintained bed liners.
3. All trucks will have ambient sensitive backup warning devices.
