- Complete a Washington State Criminal History Report

OBLIGATIONS:

- Attend a Board Member Orientation to be schedule in late August/early September
- Attend 1 all-day retreat (typically on Saturday or Sunday in September/October)
- Attend 2 meetings per month from September to June (on the 2nd and 4th Wednesday) at different locations throughout the City of Bellevue (includes community centers and high schools)
- Notify via phone or email at least 24 hours prior to an absence from a meeting, unless it is due to an emergency
- Participate as a representative or liaison to community organizations as needed

- Attend the Annual Youth Link Board Gumbo Night, from 5:00 - 7:00PM (usually in March)
- Attend the Annual Community Leadership Awards Ceremony, from 6:00 - 8:00PM (usually in May)
- Act as a representative of the Youth Link Board at public events and in the community as needed
