

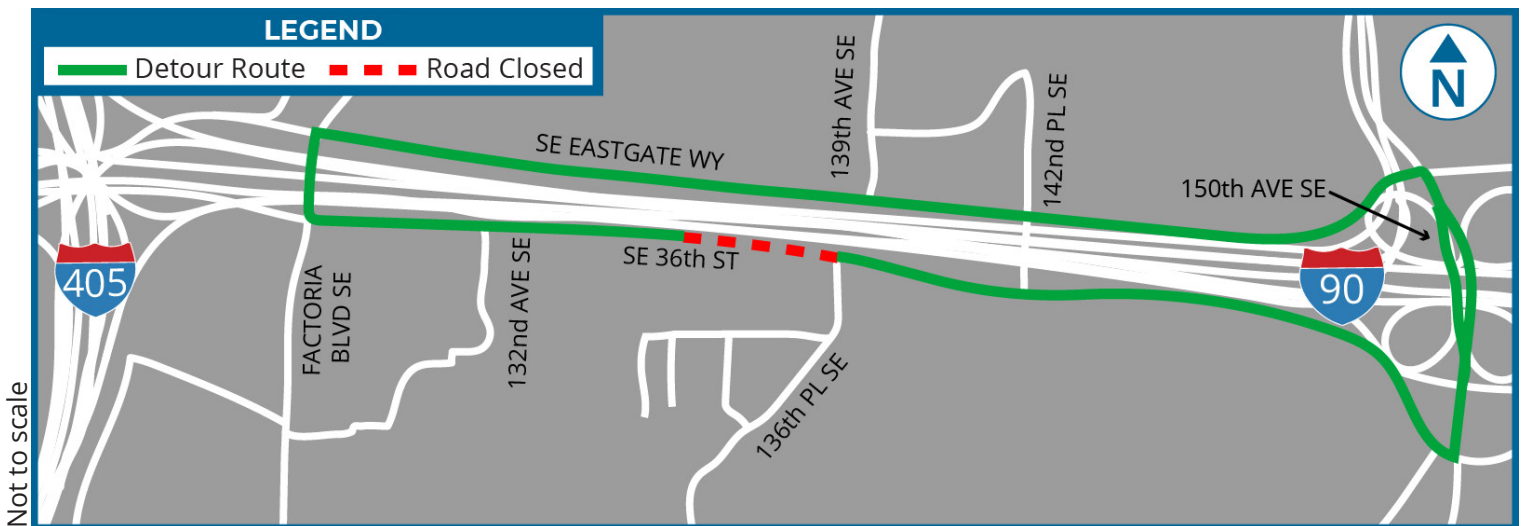

Mountains to Sound Greenway Trail 132nd Avenue SE to 142nd Place SE

July 2021

Road Closure and Detour



As part of the Mountains to Sound Greenway Trail construction project, it will be necessary to close a portion of SE 36th Street between 132nd Avenue SE and 142nd Place SE to build traffic islands, complete utilities work and restore the roadway (see map). This new section of the Trail is expected to be open by the end of 2021. There will be four continuous closures (24 hours a day); the dates and times are noted below. Construction schedules are subject to change and often do.

- **Bicycle access** is available via the vehicle detour or on the sidewalk on the south side of SE 36th Street.

Safety

- Follow police and flagger instructions.
- Drive slowly near the construction zone.
- Plan your travel in advance.

- Thanks for your patience as work to complete the new segment of trail continues.
- Please notify your customers, clients and employees of the detour.
