# Eastgate ADA Curb Ramp Replacements:

Intersection Improvements at 167th Avenue SE/SE 46th Street

August 2021

The Bellevue Department of Transportation will be making improvements to the intersection of 167th Avenue SE and SE 46th Street, adjacent to Cougar Ridge Elementary. Minor improvements will also be made to two nearby intersections on SE 46th Street, at 165th Avenue SE and 168th Avenue SE. These improvements are part of a project to replace 40 existing curb ramps in the Eastgate neighborhood with ramps compliant with the Americans with Disabilities Act (ADA).

The following improvements will be made at the 167th Ave SE/SE 46th St intersection to increase accessibility and safety:



Replace existing curb ramps with ADAcompliant ramps



Add a marked crosswalk and reduce the crossing distance on the north side of the intersection



Rebuild the median crossing on the west side of the intersection



Repave the intersection and restripe existing marked crosswalks

## What to expect

- Construction: Mid-August through November. Construction schedules are subject to change and often do.
- Work hours: 7 a.m.-6 p.m., adjusted as needed to minimize impacts to school drop-off and pick-up.
- **Traffic control**: Follow flaggers' instructions as they assist with traffic control.

## **Funding**

Construction funding comes from the Pedestrian Facilities Compliance Program and is supported by the Eastgate Annexation funds from King County. The total estimated cost for improvements to all 40 curb ramps is \$1 million.
