WELCOME AND ROLL CALL:	The meeting was called to order by Abigail Brown and the roll call taken.

APPROVAL OF MINUTES:	May minutes approved.

#### **BNOA TOPICS OF DISCUSSION:**

- ✤ In-person/Zoom/Hybrid BNOA meeting discussion:
  - Majority of members are suggesting staying on Zoom for various reasons; health and safety in precaution of Covid19, convenient and time saving, increasing gas prices, able to join when out of town, eliminating set-up at NBCC, technological challenges of hybrid meetings, etc.
  - Some members suggested having an in-person meeting quarterly to meet and connect with each other.
  - If accessibility is an issue, hybrid model is suggested to accommodate.

- Motion moved to stay on Zoom at this time for 5 months and reevaluate in November. Voted and approved.
  - This does not pertain to committee meetings; each committee is requested to discuss their preferences and decide.
- Planned Changes in Medicare:
  - <u>Accountable Care Organization (ACO)</u> <u>Realizing Equity, Access, and Community Health (REACH) Model.</u>
  - Diana suggested not adding this to the agenda as many areas about it are unclear and too complex.
  - Desiree is suggesting adding it to the agenda to follow it as this change will have some significant changes to Medicare.
  - Motion moved to add ACO REACH to the agenda, *not* to support it but for the purpose of collecting addition information to maintain awareness and distribute information with the help of the Outreach Committee. Voted and passed.
- Definition of senior for Bellevue Saving this topic for the next meeting due to lack of time but requested to put it at the top of the agenda next time.

## HUMAN SERVICES UPDATE: Christy Stangland

- Commissioners are in process of reviewing the 135 applications. Requested funds are over double the available funds.

- Commissioners will have two meetings in June and two meetings in July, then will be finalizing the recommendation at the beginning of September.

## HOUSING AND TRANSPORTATION REPORTS: Committee Report.

KSC members unable to attend today, are taking down the annual senior art show at Merrill Gardens.

Some H&T members attended City of Bellevue's Comprehensive Plan Update open house at Stevenson Elementary school on 5/14, event had good turnout, plenty of seniors, senior commentary covered same issues we've been debating for years.

COVID test kits available at NBCC, Uncle Fed also giving away (8) free masks and home tests upon request at *COVID.gov*. Folks are tending to mask up more than before in public arenas, consensus is that masks are here to stay, according to personal comfort level.

Gazel shared City of Bellevue's chart entitled *Increasing Income Disparity*, monthly income gap has increased nearly 44% between 2010 and 2019. Also viewed several of the slides from the Comp Plan 5/14 open house.

Small group of H&T meeting weekly to put together a "fact sheet"/position paper on older adults in Bellevue. Will ask that older adults be considered as a separate demographic when planning affordable and accessible housing.

- KSC has joined the committee and have been a valuable addition to share information and ideas.
- Expansion of 300~500 units being planned for Evergreen Court which currently has around 80 units, committee would like to follow up for more information.
- Abigail and Gazel went on the affordable housing bus tour through the City of Bellevue and Abigail felt that there are many affordable housing options that are not widely

communicated. The "missing middle" where seniors with a fixed income fit in, won't make the new AMI qualifications that is constantly changing. People need to be more aware of the affordable housing options. Affordable housing should be differentiated from senior housing so that different groups of people are the focus on particular types of housing and availability.

- Abigail and Gazel are suggesting inviting Mike Stanger from ARCH to speak to BNOA to illuminate different issues. The document that shows programs, qualifiers, target audience, etc. are things BNOA looks for, but many times don't know where to find them. It would be nice to know where these data came from and obtain a digital copy.
- Transportation there's a project underway to come up with an option for seniors that is outside of what is currently available through a federal grant as a pilot test to development more options, committee is waiting to hear more from this group.
- Please email Gazel if you'd like to see the compiled data.
- Diana would like to know what the city is doing to keep older adults in their homes, not only for low income but for all older adults.
- ✤ Gazel will request senior services for the next meeting's agenda item.
- Dan, please send out an email to confirm who can attend the next monthly BNOA meeting on July 7th as it falls on a holiday week.
- Abigail will be involved with the Bellevue Police Advisory Council and the Comprehensive Planning group and will be meeting monthly. Older adults need representation, none of the councils address older adults. Abigail will be speaking with them to discuss how to get representation for older adults. Please let Abigail know if you'd like to provide input on the comprehensive plan.
