- Bellevue Way Northeast, from Northeast Fourth Street to Northeast Eighth Street, 6:30-7:45 p.m.
- Northeast Sixth Street, from 105th Avenue Northeast to Bellevue Way Northeast, 6-7:45 p.m.

During the closures on Bellevue Way, visitors to the Bellevue Arts Museum may park in the underground parking at Lincoln Square North (Westin Hotel) and Lincoln Square South (W Hotel). Both garages are accessible from 105th Avenue Northeast.

## Somerset chooses removal of invasive vegetation from greenbelts for NEP funding

Thanks to all Somerset neighbors who participated in the Neighborhood Enhancement Program over the past several months. The program kicked off in April, with the city receiving



136 resident-identified project ideas for how to spend the \$217,000 budget allocated for the Somerset neighborhood area.

City staff reviewed each of the submitted project ideas for accessibility, feasibility, cost, timeline and maintainability, and, in September, presented 11 projects on the ballot for consideration. One project – removal of invasive vegetation from Somerset greenbelts – took the most votes.

The project will focus on removal of blackberry and ivy from city-managed greenbelts in Somerset, including Somerset Park, Forest Park open space, Forest Park Meadows open space, Eastgate Park, Westwood Highlands open space and areas in the Coal Creek Natural Area.

The work will include grubbing blackberry and ivy from the forest floor and removal of ivy growing up native trees and other non-native invasive weeds as they are encountered. City staff will plant native trees and shrubs and water and otherwise maintain them until they are established and self-sustainable.

NEP is a city-funded, capital improvements program that allows residents to propose and select small-scale projects that improve the quality of life and enhance the character of their neighborhood.

The current \$5 million allocation NEP has now been distributed over the past seven years among Bellevue's 14 neighborhood areas, based on the number of households in each area. NEP rotates through two neighborhood areas per year.

In 2023 a new seven-year NEP cycle will begin, with funding available to the Eastgate/Factoria and Cougar Mountain/Lakemont neighborhood areas first. Eastgate/Factoria will kick off in late January with a virtual public meeting. Look for NEP to come to Cougar Mountain/Lakemont in early April.

### NEP Project Spotlight: Phantom Lake Wetlands Improvements

Residents in the Lake Hills neighborhood will now enjoy improved wetlands near Phantom Lake Park with the restoration of roughly two



acres of wetland buffer around the lake. Invasive plants were removed, and native conifer trees and shrubs were added, which will improve water quality and wildlife habitat. Area residents voted for this project in 2019. Thanks to Bellevue Parks managers Jammie Kingham and Rick Bailey for bringing this project to completion.


## Weigh in on draft emergency water supply plan

The city is working on a master plan to reduce impacts to water service after a severe earthquake. A draft plan has been developed, and residents and businesses are invited to weigh in as part of the State Environmental Policy Act review.

### Why is plan needed?

Bellevue's water system and regional water supplies are vulnerable to severe earthquakes. Studies predict most customers would have no water service for up to three months while the system is repaired.

The master plan sets goals and recommendations to improve system resilience and reduce disruption. Recommendations include



continuing existing programs such as water main replacement and adding facilities such as emergency wells.

## What has been done so far?

A customer survey was conducted in 2021 to inform the plan. Survey results are included in the draft plan. City staff also regularly engaged the Environmental Services Commission in public meetings during plan development.

## View the draft Master Plan and provide feedback.

### Prepare for winter weather

Colder temperatures have arrived, and with the official start of winter only a few weeks away. Are you and your household prepared? The city's Transportation Department has been fully prepared for winter weather response since the start of November. We have 15 trucks that can be configured with plows and sanders. During a storm, 60 staff from several departments are ready to respond. They work 24/7 in 12-hour shifts to clear roads. Streets are prioritized for plowing based on several factors, such as access for emergency vehicles and traffic volumes.

Here's some information and tips for staying safe:

#### Be prepared:

Install snow tires or have tire chains ready.
 Practice putting on your tire chains now!



- Have an ice scraper/snow brush and other essentials for your car. Visit <u>WSDOT.wa.gov/</u> <u>winter</u> for a checklist of other items to have in your car to be prepared.
- Make sure your car's defrost works and that the wipers are in good condition.
- Purchase a snow shovel. Clearing your sidewalk of snow helps keep people who are walking and rolling safe.
- Buy shoes with good grip, ice grippers to put on your shoes, a walking stick or other mobility safety devices to help with walking in winter conditions.

#### Who to contact:

- For life-threatening emergencies, call 9-1-1.
- To report flooding, blocked or hazardous streets and sidewalks, fallen trees and similar problems, call the city's 24-hour response line at 425-452-7840 or use the MyBellevue app. 9-1-1 is for emergencies only!
- Call Puget Sound Energy at 1-888-225-5773 to report a power outage. Do not touch or drive over downed power lines.

#### Other tips:

- If possible, stay home and avoid driving during winter conditions. If you must drive, consider the conditions — it may take more time to stop and turn.
- Clear snow off all your windows and roof prior to driving.
- Wear bright colors or reflective clothing if walking or rolling at night.



## Policies take shape for Bellevue's increasingly busy curb space

The curb space in Bellevue's densest neighborhoods, long used for just parking and vehicle lanes, is a lot busier these days. Ride services (Lyft or Uber), delivery vans, employer shuttles, rental scooters and even on-street dining all compete for curb space in downtown, Wilburton and BelRed.

With input earlier this year from hundreds of people who use that border space between streets and sidewalks, the city is drafting policies and a long-range plan for designating, maintaining and operating curbside areas. Centralizing

curb management, streamlining permitting for curbside uses and improving enforcement are all in the mix. To ensure curb spaces are easily available, the city will also consider equitable pricing strategies.

Currently, curb space in the city is managed ad hoc, and enforcement is light and spread across multiple working groups. At times this has created less-than-ideal traffic conditions, such as doubleparked vehicles and vehicles blocking bike lanes. Additionally, applying for permits for employer shuttles, on-street dining, food trucks, etc. can be overly burdensome.

A Curb Management Plan will allow for informed decisions on how curb spaces should be managed as the city grows and competition for this urban space increases. The new framework will help the city provide clear feedback to developers, residents and others about the intended use of the curbside.

Next steps include council taking final action on curb policies at the Dec. 12 meeting. Residents and other users can also provide input on curb management recommendations at the monthly Transportation Commission meetings in early 2023. A draft CMP will be available for public review in early 2023, followed by Transportation Commission plan refinements and a final CMP presented for council consideration in spring 2023.
