NEP IS...

- **Council-directed, City-Funded, Capital Improvements Program**
- **Provides RESIDENTS the opportunity to PROPOSE and SELECT enhancement projects for their individual neighborhood area**
- **\$5 Million BUDGET distributed among 14 NEP designated neighborhood areas**
- **Area funds allocated based on the number of households in each Neighborhood Area**
- **Rotates through 14 Neighborhood areas over seven-year period – TWO AREAS per year (2015-2022)**
- **Program supported by multiple City departments – Community Development, Parks, Transportation, Utilities**
- **Currently 25 NEP capital projects in progress around the city in 9 of the 14 neighborhood areas**

PROJECT CRITERIA

AFFORDABILITY

PROJECT COSTS MUST NOT EXCEED THE FUNDING ALLOCATION FOR THE NEIGHBORHOOD AREA

CONSISTENCY

PROJECTS MUST BE CONSISTENT WITH CITY PLANS AND POLICIES

FEASIBILITY

PROJECTS MUST BE PRACTICAL AND ACHIEVABLE FOR THE CITY

IMPLEMENTATION

PROJECTS MUST BE DESIGNED AND CONSTRUCTED WITHIN 3-5 YEARS OF SELECTION

MAINTAINABILITY

PROJECTS MUST NOT REQUIRE MAINTENANCE THAT IS BURDOMESONE TO THE CITY

PUBLIC BENEFIT

PROJECTS MUST BE LOCATED ON PUBLIC PROPERTY, EASEMENTS, OR PROPERTY DESIGNATED FOR PUBLIC USE, AND MUST BENEFIT THE GENERAL PUBLIC

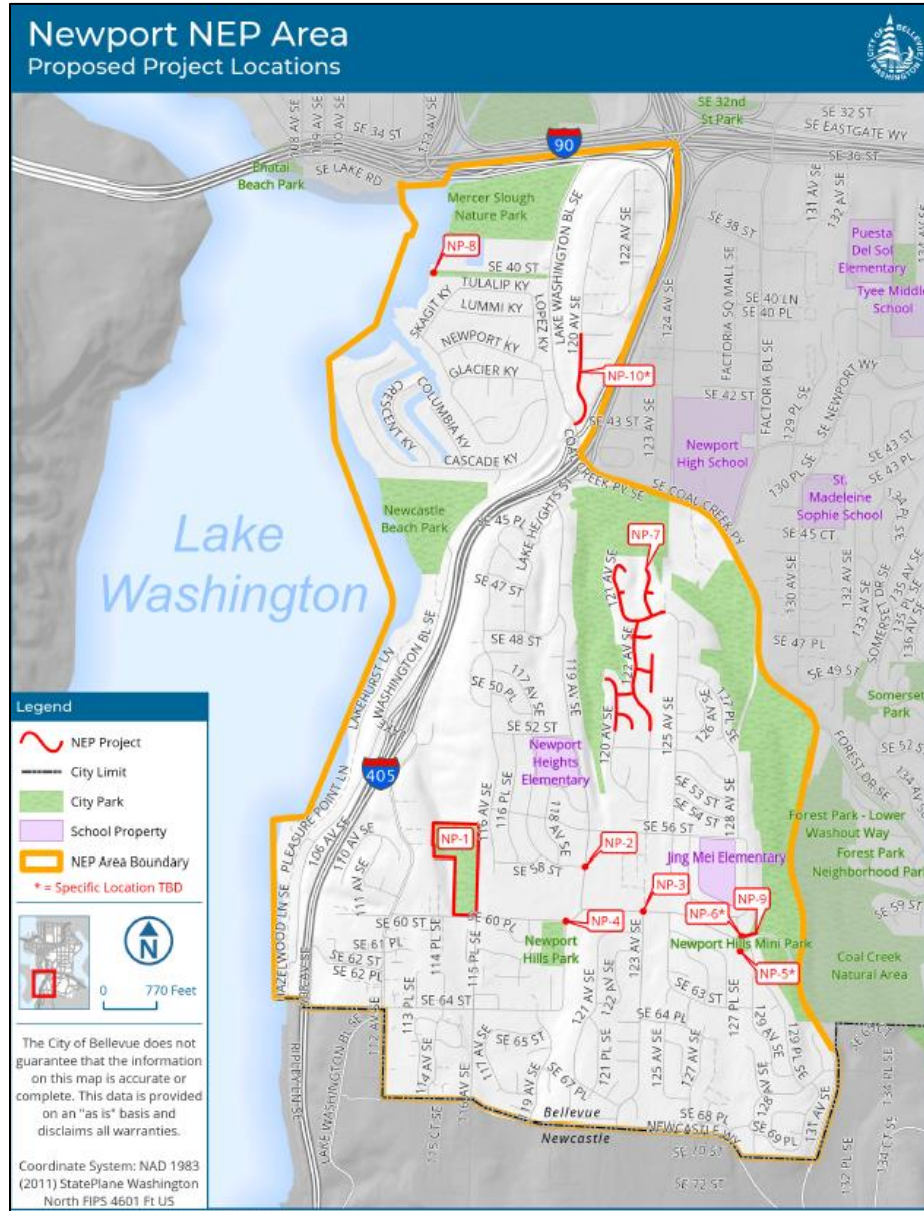

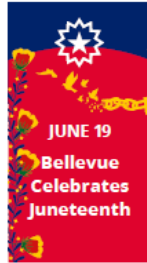

Juneteenth observations recognize historic, symbolic day of freedom

City of Bellevue facilities will be closed on Monday, June 20, in observance of Juneteenth and the city will raise the Juneteenth flag at city facilities from June 17-24.

Although the Emancipation Proclamation came 2½ years earlier on January 1, 1863, many enslavers continued to hold enslaved Black people captive after the announcement. Juneteenth became a symbolic date representing African American freedom, and we recognize this day as the promise and lasting hope for freedom for African Americans. We gather and celebrate family, remember the past and honor the commitment to continue the essential work for attaining racial equity and social justice.

Examples of services provided by the program include:

- One-on-one, in-person career exploration and entrepreneurship navigation
- Connect to community and state-based employment and business resources
- Job training, job search, and job application resources
- Résumé and interview support
- Internship and apprenticeship resources
- Small business information and resources
- Business licensing and permitting

Mini City Hall has been serving customers for over two decades in the community, specializing in personalized customer services provided by friendly staff in multiple languages. Many local nonprofit organizations and programs also have office hours at MCH. Besides processing city water bill payments and selling pet licenses, Mini City Hall offers information and referrals for a long list of items, including Medicare, ESL classes, affordable housing and shelters, legal and financial services, family counseling, childcare, job search resources, senior services and resources for people with disabilities.
