### \*NOTES:

- 1) **Will take effect for field use beginning in March of 2023.** (2022 rates will apply for Jan-Feb 2023 field use.)
- 2) If unsure of field category, please refer to the Fees by Field file.
- 2) To qualify for the Bellevue Resident Youth rate, 80% or more of the participants must live within the City of Bellevue or Bellevue School District boundaries AND NOT be for Commercial use.
- 3) Adult fees also apply to field use by adults & youth combined or Commercial use.
- 4) We offer a Non-Peak Rate on the full synthetic turf fields that applies to use prior to 3:30 pm when the Bellevue School District is in session. The Non-Peak Rate is the same as the Bellevue Resident Youth Use rate, regardless of user group status.
- 5) Game Prep Fee (in addition to Field Rental Fee) applies to first baseball/softball field use after field prep, if requested. **There is now a Partial Game Prep Fee applied when groups that are only offered a fresh drag.**
- 6) To receive the Youth Resident or Youth Non-Resident Fee, organizations and schools must be registered as a Non-Profit with State of Washington and/or with the IRS. Organizations and schools must also offer a Scholarship program or reduced fee policy for those that require such. Documentation of this policy must be provided to the City of Bellevue upon request.
