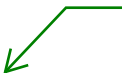

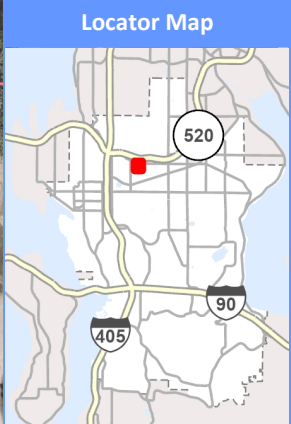
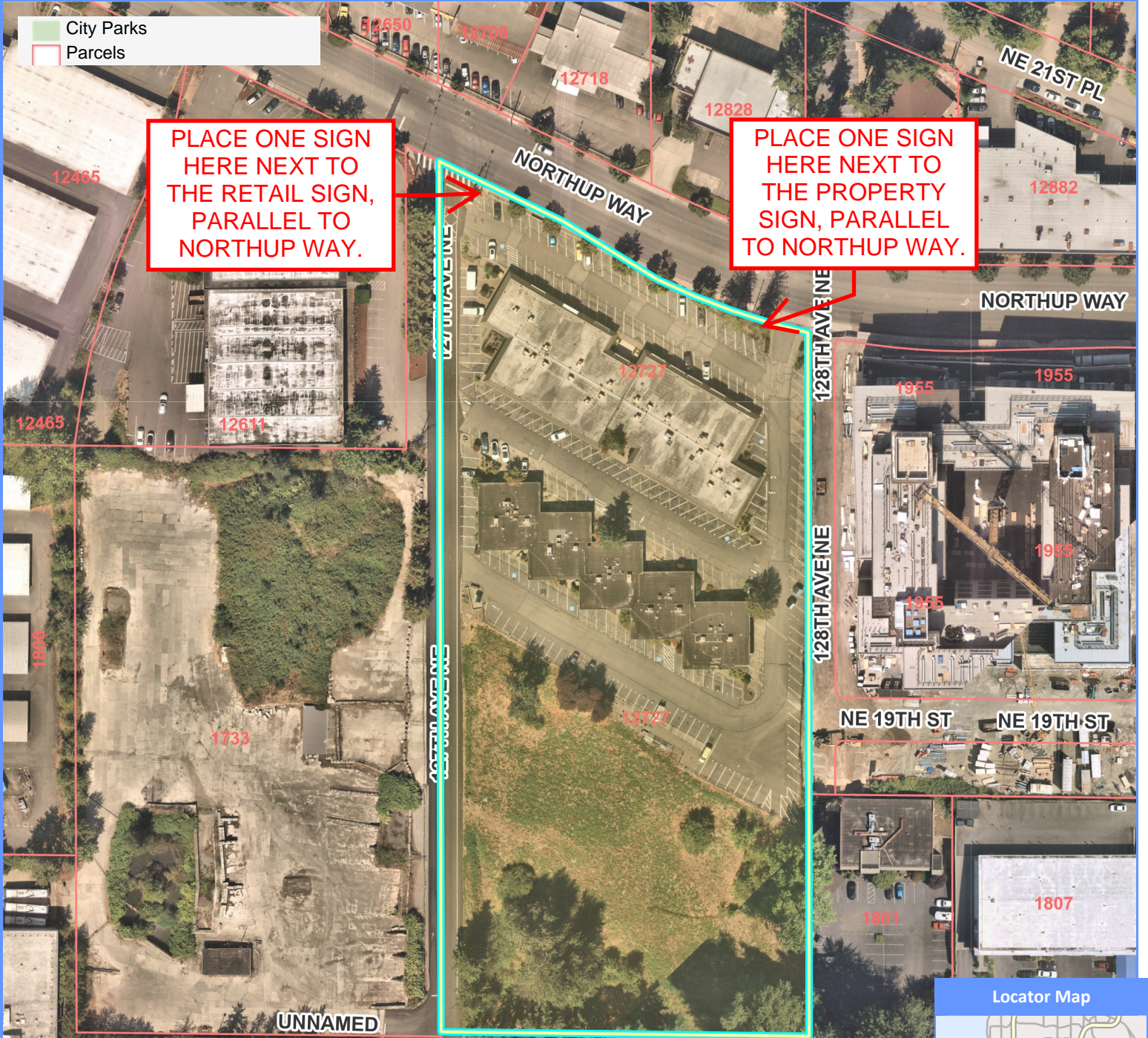
# SpringVue Townhomes - Sign Vicinity Map

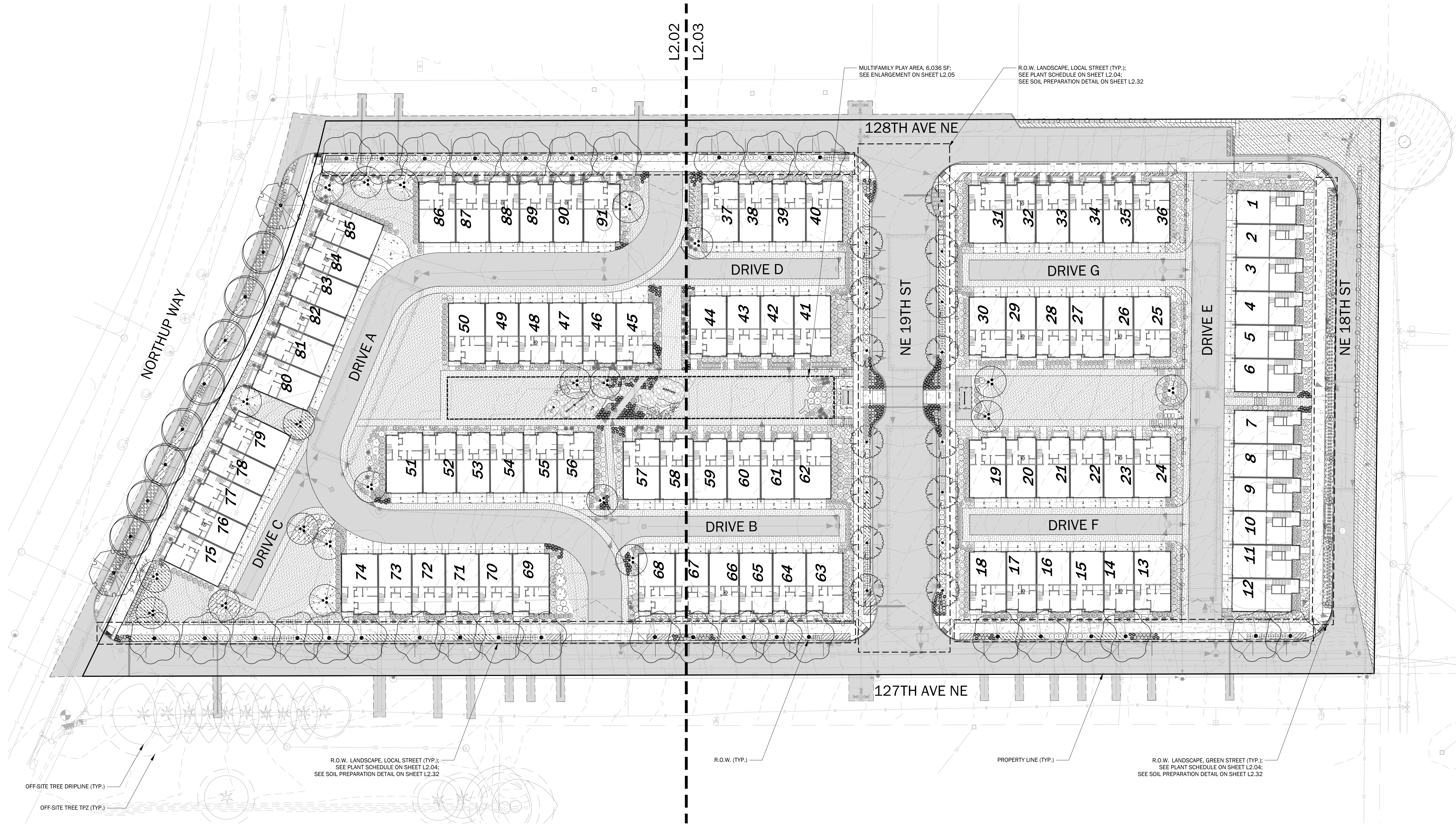
