Tea, HP Smokehouse BBQ, Isidros, La Panadeia, Langostino Sushi Burrito, Mexicuban, Organic Juice Bar & Gyros, Ray's Food, Seoul Bowl, and Zieglers Bratwurst Haus. More food trucks will also be around the perimeter of the park, and include Ben & Jerry's, Kornman, Kulphi LLC, Nothing Bundt Cakes, Pioneer Popcorn, Road Dawgs and Samijon's Shaved Ice.

The Family Fun Zone will offer family entertainment and a kids area starting at 5 p.m.

Festivities also kick off at 5 p.m. on the Amazon Entertainment Plaza with Lady A. performing blues and soul, followed by folk/rock band Laurel Canyon Legacy at 7 p.m. The Bellevue Youth Symphony Orchestra will have a pre-fireworks performance starting at 9:15 p.m.

To set the stage for the fireworks, which start at 10:05 p.m., Bellevue Fire Department's Honor Guard will present the colors at 9:50 p.m. followed by a performance of the National Anthem by Highland Middle School Choir before the fireworks begin in a synchronized show set to live musical accompaniment by the Bellevue Youth Symphony Orchestra. After the fireworks, the youth orchestra continues with a post-fireworks show.

### **Getting there**

Several streets will be closed to vehicle traffic near the park for safety and to minimize delays. Please be patient, observe posted signs and obey police officers directing traffic. Street parking on nearby residential streets is prohibited and be aware that violators may be towed.



### Neighborhood Enhancement Program updates

Eastgate/Factoria Neighborhood Area residents: Submit your ballot for your top three project choices by July 21!

Be a part of the voting, and tell us which projects you'd like to see funded with the \$370,000 in available funds that the city has allocated for your neighborhood area.



Simply return the postage paid ballot included inside the voter's pamphlet that each Eastgate/ Factoria neighborhood household received in June.

Voting is by mail only and is limited to one ballot per household address, allowing you the opportunity to vote in priority order. Responses will be tabulated with the highest-scoring projects receiving funding.

Project specifics and a map showing the project locations for the ten Eastgate/
Factoria NEP projects can be found on the City of Bellevue's NEP website in the Eastgate/Factoria Neighborhood Area section at BellevueWA.gov/nep.

Ballots must be postmarked by Friday, July 21 to be included in the voting process. Remember to include your address, and for those in multiple housing units, your apartment or condo number must be included for your vote to be counted.

The Neighborhood Enhancement Program is a city-funded program that allows residents to propose and select modest, capital projects to enhance their neighborhoods. The program rotates through the city's 14 NEP neighborhood areas over the course of seven years, serving two areas each year. The \$7 million program allocation is distributed among each of the NEP neighborhood areas, according to the number of households in each area. In 2023, NEP is available in the Eastgate/Factoria and Cougar Mountain/ Lakemont neighborhood areas.

As we face increasing global climate impacts, planning for a sustainable future is a critical part of every healthy city. To ensure that Bellevue's residents will continue to enjoy our "City in a Park" and a thriving natural and human environment for many generations, the city is working to implement the Environmental Stewardship Plan, a key element of the City Council Vision.

To support the Comprehensive Plan Periodic Update, Bellevue is conducting environmental assessments and reports that will help the city shape our more sustainable future.

The projects sit at the intersection of environment and community planning and illuminate how the health of Bellevue's environment impacts residents, and how residents impact the environment.

Over the next three months, the city invites you to learn more about the reports and our environmental planning process. From July to September, the city is hosting Summer Sustainable Bellevue Lunch and Learns on the fourth Tuesday of each month. The Lunch and Learns will be an opportunity to get more involved in efforts to build a more sustainable future.

Topics to be covered will include the Air Quality and Land Use Planning Report, the soon-to-be-released Climate Vulnerability Assessment, the Racially Disparate Impacts report, the 2021 Tree Canopy Assessment and other sustainability subjects, with a focus on environmental justice and equity.

Through this series, Bellevue residents will gain a deeper understanding of sustainability in Bellevue. Community members will have the opportunity to ask questions and participate in short discussions about these topics.

The first Lunch and Learn will be held Tuesday, July 25, noon-1 p.m., and the topic is "Air Quality and Land Use."

Other Summer Sustainable Bellevue Lunch and Learns will be held noon-1 p.m. on Aug. 22 and Sept. 26. Topics and more details can be found at the registration link.

## If you knew you could save a life, would you?

It happened in an instant. While sitting at a hair salon, a Bellevue firefighter's phone alerted her to a medical emergency where someone needed cardiopulmonary resuscitation (CPR). She wasn't on duty. She wasn't even within Bellevue city limits. But the PulsePoint app she

downloaded a couple years prior gave her the exact location of a patient in cardiac arrest at that moment. She knew she could get to scene before the closest first responders. The app told her that, too! Equipped with the knowledge that every second counts when a heart stops beating, she left the salon chair, found the patient and immediately began CPR compressions. That day she



saved a life. And she credits it all to PulsePoint.

PulsePoint Respond (mediconefoundation.org/pulsepoint/) is a free app that empowers residents to provide life-saving assistance to victims of sudden cardiac arrest. Download the app, indicate youre trained in CPR and willing to assist in case of an emergency, then get notified if youre in the vicinity of someone needing CPR. Notifications happen simultaneously with the dispatch of first responders. Activations are limited to public places and will not send civilian responders into private locations.

Bellevue Fire encourages everyone to download and sign up for PulsePoint. If you'd like to learn CPR or need a refresher, sign up for one of our monthly CPR/AED courses

## International fraud alert from Bellevue Police Department

近期频繁出现诈骗,偷盗和个人信息盗窃的案件。诈骗方假冒中国政府或者警方的身份联系受害人,以威胁拘捕或遣送的方式诱导受害人配合调查,汇款解决问题。诈骗手法通常包括电子汇款,电子礼品卡和现金交易。



在最近的一起案件中,诈骗方从当地电话公司盗取号码,用假冒身份得到受害者的信任,受害者汇款之后发现被骗。数额巨大。

如果有人声称他们是海外政府工作人员并索要钱财, 请务必留意。在您不能确认是否遇到诈骗情况时,请 及时拨打咨询您所在地方当局的警察。 Bellevue Police are seeing increased fraud, theft and identity theft cases involving people claiming to be Chinese government or law enforcement officials. The suspects contact the victim, claim they are in trouble and must pay money to fix the problem. They even threaten that they may be arrested or deported. The scams take many forms, including wiring money, purchasing and electronically sending gift cards or telling someone to withdraw cash and hand it over.

In one case, the suspects cloned phone numbers from a local cell phone company and sent the victim "official looking" credentials, which prompted the victim to believe it was real. These are scams, and victims are losing tens of thousands of dollars to these fraud schemes.

Please do not reply or cooperate with anyone claiming to be an overseas official asking you for money. If you don't know them, don't trust them. Instead, call your local police department, and they will check it out. It is better to take the time to verify than to potentially lose thousands of dollars.

## Important information about hearing loss

Hearing loss has been associated with social isolation and a greater chance of developing dementia, but recent research suggests that use of hearing aids by persons with hearing loss may reduce the chance of dementia. The National Institutes of Health (NIH) reports that among adults aged 70 years and older with a hearing loss who could benefit from hearing aids, less than 30% has ever used them.

One of the reasons for not wearing hearing aids has been their appearance. However, hearing aids are much smaller and less visible than in the past. Another reason that many have not purchased hearing aids is the high cost. The average price for a pair of hearing aids is about \$4,672, although the price can range from \$1,000 - \$8,000. Price of aids can depend on factors including client needs, the technology included and services provided.

In Washington state, Medicaid covers hearing aids for low-income children and adults. Some Medicare Advantage Plans contribute to or fully cover the cost hearing aids.

Some health care plans in Washington presently cover hearing aids. In addition, our legislature just passed ESHB 1222. Beginning January 1, 2024, this legislation requires group health plans, with a number of exceptions, and school and state employee health plans, to provide coverage for the described hearing instruments and services, at no less than \$3,000 per ear every 36 months.

Financial assistance for purchase of hearing aids and related equipment is often available, as is shown on the Hearing Loss Association of Washington website: hhearingloss-wa.org. In addition, our state provides amplified and captioned phones and other equipment to persons with hearing loss, the cost depending on one's income. Visit: dshs.wa.gov/altsa/odhh/

Over-the-counter (OTC) hearing aids are regulated by the Food and Drug Administration (FDA) and are designed for persons aged 18 years and older who have mild to moderate hearing loss. OTC hearing aids are available in stores and online.



## Spring District sewer work update

King County contractors will continue working on sewer construction this month in BelRed. Construction work will take place in the project area through October 2023. Crews are relining an existing sewer pipe to extend the pipe's lifetime for the next fifty years.

After completing installation for a temporary diversion sewer pipe in the west section of the project area (120th Avenue Northeast and 124th Avenue Northeast), sewer pipe relining to rehabilitate the permanent pipe started in June and the work will continue in July. The installation of the temporary diversion pipe in the east side of the project area (130th Avenue Northeast, 134 Avenue Northeast, Spring Boulevard and 134th Avenue Northeast, Spring Boulevard, & Northeast



Spring Boulevard) started in June and that work will continue into July as well.

### What to expect:

- Typical work hours are 7 a.m. 7 p.m. weekdays with occasional night and weekend work. However, contractors will be present onsite 24-hours a day for monitoring and refueling activities.
- Expect traffic detours, equipment staging and closures of streets, sidewalks, trails, bus stops, driveways and bike lanes.
- There will be noise and odor from the temporary pumping system and other construction activities.
- Sewer service will be maintained.

## Help keep Washington roadways clean!

Did you know that each year, more than 26 million pounds of litter end up on Washington roadways? In 2022, the Washington State Department of Ecology collected more than 5.4 million pounds of litter, costing almost \$6 million in response and cleanup costs. However, we can all help!

A few reminders to help keep Bellevue and Washington clean:

- Keep a litter bag in your vehicle.
- Throw away trash when you get to your destination.
- Always cover and secure loads in your vehicle.

Unsecured loads can harm the environment and our community. More than 300 crashes in Washington, some causing injury or death, are caused by unsecured loads each year.

## WSDOT begins heavy summer construction season

You will see lots of WSDOT crews working this summer on and near state highways, and that means closures, delays or congestion. In Bellevue, you can expect to see construction on major projects this summer, including the I-405/Renton to Bellevue Widening and Express Toll Lanes Project, I-90 Sunset Creek Fish Passage, SR 520 Overlake Access Ramp and I-405 seismic strengthening of bridges.

Here are some suggestions to help you keep moving:

- Stay informed there will be lots of projects with multiple construction stages and changing road conditions over time, so staying up to date as you plan your travel and before you head out will be key.
- Use transit and keep in mind more people may be using these options so they may be more full than usual.
- If you can't delay your travel, give yourself plenty of extra time to reach your destination.
- Pre-program vehicle radios to 530 AM and 1610 AM for highway advisory radio alerts.

- Carry extra food and water as an added precaution for emergencies or unexpected stops.
- Heed all construction warning signs, closures or detour directions; they're there for your safety.
