# 124th Avenue NE Corridor Improvements: Ichigo Way to Northup Way

The Bellevue Transportation Department continues making safety and mobility improvements along 124th Avenue NE between Ichigo Way and Northup Way. This project will enhance access and improve traffic flow for freight and for people who walk, roll, drive and take transit. Additionally, the project is part of the BelRed Plan and transportation vision supporting planned growth and economic vitality in the area.

### Improvements include:



Raise and widen 124th Avenue NE to five lanes



Add a multi-purpose pathway on the west side of 124th Avenue NE, between NE 16th Street and Ichigo Way only



Add sidewalks on both sides of 124th Avenue NE, separated from the street by landscape planters



Construct a culvert that fish and wildlife can navigate



# What to expect

Work hours: Monday-Friday, 7 a.m.-6 p.m.

**Lane closures:** Intermittent single lane closures are anticipated throughout the life of the project.

**Road closures:** Coming this summer. In order to raise the roadway and replace the existing culvert, 124th Avenue NE between Ichigo Way and Northup Way will be closed to through traffic for approximately six months.

**Access:** Select access to businesses along 124th Avenue NE will be maintained during the closure and others via a detour. Pedestrian and bicycle access will be maintained via a detour.

**Safety:** Thank you for your patience during construction and for doing your part to be safe near the work zone. Please follow flaggers' instructions, electronic and detour message signs.
