





# **CONSTRUCTION ALERT** 124th Avenue NE Corridor Improvements:


Ichigo Way to Northup Way Road Closure

The Bellevue Transportation Department continues enhancing access and improving traffic flow along 124th Avenue NE between Ichigo Way and Northup Way for freight and for people who walk, roll, drive and take transit.

Beginning **June 1**, 124th Avenue NE between Ichigo Way and Northup Way will be closed to through traffic for approximately seven months to raise the roadway and replace the existing culvert for fish and wildlife.

## What to expect

**Schedule:** Construction is weather dependent, and schedules are subject to change and often do. For the latest updates, subscribe to receive email or text alerts at <u>BellevueWA.gov/ichigo-northup</u>.

**Construction duration:** Road closures take place **June 1 through February 2024**, with full project completion anticipated in summer 2024.

**Road closures:** 124th Avenue NE between Ichigo Way and Northup Way will be closed in both directions to raise the roadway and replace the existing culvert.

**Work hours:** Monday-Friday, 7 a.m.-6 p.m.

Access: Some access to businesses will be maintained on 124th Avenue NE during the closure. Other access will be maintained via a detour on 120th Avenue NE, Northup Way or 127th Avenue NE.

Pedestrian and bicycle access will be maintained via a detour on 120th Avenue NE, Northup Way or 127th Avenue NE.

Please follow all pedestrian and bicycle detours for your safety.

**Safety:** Thank you for your patience during construction and for doing your part to be safe near the work zone. Please follow flaggers' instructions, electronic and detour message signs.
