### Essential Duties and Responsibilities

- Perform a wide variety of maintenance, installation, and repair-related tasks to the City of Bellevue’s water infrastructure.
- Use backhoes, hydro-excavators, 7-yard dump trucks, truck and trailer combinations, air hammers, and trench shoring equipment.
- Perform maintenance to water mains, service lines and fire hydrants.
- Conduct traffic control / flagging in the city’s rights-of-way.
- Respond to emergency calls after regular business hours (overtime): customer requests, main and service breaks.

### Your Compensation

Starting pay is dependent on your experience working with underground utilities, most entry level workers start at step one. After completing a training matrix and demonstrating a journey level of competence (usually between year 1.5 and 2.5) team members are advanced to the Journey Level Skilled Worker.

### Working Conditions & Physical Demands

- Must be able to lift up to 90 lbs. and engage in considerable pulling, pushing and climbing.
- Work is done mostly outdoors in all types of weather conditions. Common hazards include traffic, underground lines, chemicals and equipment.
- Individuals must have adequate hearing and visual acuity to successfully perform the essential job functions and requirements of the position.
- Individuals must be able to hear, speak and understand verbal communication and other outside sound sources. Vision abilities include close, distance, color, peripheral vision, depth perception, and the ability to adjust focus.
