## Agenda Item #1: Intellectual Freedom Committee Presentation

Amy MacClanathan, Assistant Operations Manager for Lake Hills and Newport Way Libraries, and Imtiaz Arshi, Public Services Assistant at Bellevue Regional Library, gave a presentation on Intellectual Freedom. KCLS is in the middle of a year-long campaign to celebrate the Freedom to Read, as well as promote the importance of Intellectual Freedom. KCLS believes that intellectual freedom is a basic human right as outlined in Article 19 of the UN's Universal Human Rights document. All community members should have free access to information.

Some key highlights from the presentation include:

- Libraries are limited public forums. Libraries protect confidential nature of information requests.
- Libraries aren't here to defend specific titles but a person's right to read, view or listen to information
- Libraries must balance their scope with demand. KCLS seeks to represent all community members in their collections.

• Libraries offer spaces where community members are empowered to access information. Information needs are personal.

Amy shared a helpful summary quote: "We have something for everyone but not everything for someone."

KCLS staff answered questions from board members:

- Kat asked if the presentation was available to the public. Staff shared that any group can request this presentation and materials from it are also available on the KCLS website.
- Jim asked several questions about book bans. Are book ban efforts mainly grassroots or organized? Have we had book challenges in the Bellevue region? Staff responded that book bans are a mix. We have had book challenges in Bellevue, but most have been verbal challenges. As well most of the recent challenges have been directed at programs such as Rainbow Story Time. Staff also developed a material evaluation policy over the past year to clarify materials selection and purchasing decisions. - Board members asked if staff received de-escalation training.
