Bellevue City Council to meet on Tuesdays starting April 16

The Bellevue City Council meetings will move from Monday nights to Tuesdays beginning April 16. The meetings start at 6 p.m. in council chambers at Bellevue City Hall. They are also accessible virtually via Zoom. This change in meeting day gives the public, city staff and councilmembers additional time for final meeting preparations each week.

During the Feb. 12 council meeting,

councilmembers unanimously voted to move forward a proposal to change the council meeting day to Tuesday to give more time between publishing the meeting agenda and holding the meeting, allowing community members and councilmembers additional time to review agenda items and become informed on citywide topics.

Neighborhood Enhancement Program Updates

The Neighborhood Enhancement Program (NEP) is a \$7 million, city-funded capital improvements program that allows residents to propose and select small projects that



improve their neighborhood's quality of life and enhance its character. The program rotates through the Bellevue's 14 NEP Neighborhood Areas, serving two areas each year. In 2024, the program is available to the West Lake Sammamish and Northeast Bellevue neighborhood areas.

Northeast Bellevue NEP kicks off April 3!

Join your neighbors and City of Bellevue staff to kick off the **Neighborhood Enhancement Program** in Northeast Bellevue! Share your ideas for how to spend \$366,000 for neighborhood improvements. There is no limit on the number of project ideas you can submit, but all ideas must be received at City Hall or submitted online by May 7. Submit your ideas in two easy ways:

West Lake Sammamish NEP is in project scoping and review phase

City staff are in the process of evaluating and reviewing project ideas West Lake Sammamish Neighborhood Area residents submitted for their neighborhood. Eligible projects will be presented for voting on the West Lake Sammamish NEP ballot.

\$219,000 is available in funding. West Lake Sammamish residents should watch their mail for a voter's pamphlet and ballot to arrive in early June, then vote for their top three project choices. Voting is by mail only and limited to one ballot per household. A public open house is planned for June where projects on the ballot will be presented, and residents can meet with city project managers to ask questions. Watch for more details!

NEP Project Spotlight

During the 2017 Neighborhood Enhancement Program process, residents in Northeast Bellevue proposed and selected a landscaping project along 164th Ave NE, between Northup Way and NE 8th Street.

With support from a Washington State Department of Ecology grant and the Community Development and Parks and Community Services departments, the project is now complete, and pedestrians can enjoy an enhanced experience with new plants and trees in the right-of-way. The appearance of the areas has not only improved, but there is also increased retention and filtration of stormwater in the newly installed bioretention swales.



Ewe won't want to miss this! Bellevue's Annual Sheep Shearing on April 27

See the sheep get shorn before the summer heat sets in at Bellevue's annual sheep-shearing celebration, on **Saturday, April 27, 11 a.m.-4 p.m.** at Kelsey Creek Farm Park, 410 130th Pl. SE.

Activities will include spinning demonstrations, children's activities, tractor-pulled wagon rides, heritage displays, animal viewing, food and more.

The annual sheep shearing at the farm taps into a 5,500-year-old tradition that originated in Central Asia. Sheep shearing started in 3,500 B.C. when people learned to spin wool to make clothing and items such as blankets.

The Kelsey Creek event originated in the early 1990s, when ever-increasing crowds came to



Kelsey Creek Farm Park each spring to watch the wool removal, a traditional farm practice. Each sheep produces six to 10 pounds of wool each year.

Admission is free, with a charge for some activities. Food is available for purchase. No ATM is available on-site. Free parking and shuttle service is available to and from the Wilburton Park and Ride, 720 114th Ave. SE, and Bannerwood Sports Park, 1790 Richards Rd.



Bellevue 2044: Comprehensive Plan Update

With almost two years of technical analysis and community input, the Periodic Update to the Comprehensive Plan is in the final stages of review. This plan will chart a course for the next 20 years and make sure that people who live, work and play in Bellevue can thrive.

Since launching the update in February 2022, the planning team has heard from over 7,000 individuals, hosted 67 events, and engaged with 60 different community groups, neighborhood associations, business groups, and other partners. A summary of all this work can be found in the Bellevue 2044 Engagement Summary.

During the month of April, the Planning Commission will continue to review proposed policy updates to different elements of the Comprehensive Plan.

Property tax relief for seniors and persons with disabilities

King County administers two state programs that provide property tax relief for qualified seniors and persons with disabilities. In King County, the income level for eligibility for both programs has been raised.

The **exemption program** reduces or eliminates property taxes on a principal residence. It freezes the taxable value of the residence as of January 1 of the first year that the exemption is received. Each year, the recipient will be taxed on the frozen value or the current market value, if lower. If qualified, the exemption renews automatically for at least three years, provided the recipient remains eligible.

The deferral program doesn't change the amount of property taxes. Instead, the State of Washington pays taxes and places a lien on the property for the taxes paid and interest. Applicants can apply for both programs at the same time.

You may qualify for an exemption this year if:

Ownership

- You owned your residence as of December 31, 2023.
- You occupied the residence for at least six months in 2023.

Age or Disability

- You were at least age 61 by December 31, 2023.
- Or, you are disabled or a veteran with a service-connected disability.
- You might qualify if your deceased spouse/ registered domestic partner had an exemption at the time of death and you were at least age 57 that year.

Income

Your household income, after deduction of qualified expenses (many medically related), was \$84,000 or less in 2023.

You can apply for a property tax exemption for 2024, 2023, 2022 and 2021. To be eligible for a refund, you must meet all the requirements for each application year and the application must be received at the assessor's office within three years of the property tax due date.

If you apply for an exemption, remember to pay your current property taxes. Processing your application may take time. If approved for an exemption, you'll receive a refund for any overpayment.

Learn more about proposed local street speed limit reduction

Speeding on local streets is the top concern heard from residents regarding traffic safety in Bellevue. In response, the Transportation Department uses a variety of different tools, like speed humps, radar feedback signs and traffic circles, to bring down vehicle speeds.

In February, the City Council directed staff to begin outreach to inform the community and answer questions about a proposal to reduce the speed limit on most local streets from 25 mph to 20 mph.

Local streets are designed primarily to provide access within neighborhoods and carry local traffic to collector arterials. A 20-mph speed limit has already been implemented in three Bellevue neighborhoods and the results have been positive. A lower speed limit would also support the city's Vision Zero effort (BellevueWA.gov/citygovernment/departments/transportation/safetyand-maintenance/traffic-safety/vision-zero), which aims to eliminate fatal and serious traffic crashes on city streets by 2030. It also represents a culture shift in how speeds are managed on local streets: Safety starts on your street!

There are many benefits to reducing the speed limit on local streets, including improving safety for children going to school in Bellevue neighborhoods, creating a more comfortable environment for people walking and rolling and creating predictable speed limits in neighborhoods.
