Boardmembers requested additional information about the process necessary for Kaiser Members to submit claims for hearing aids.
- The LEOFF 1 Boardmember terms were discussed. The Board term policy will be reviewed in 1Q24 to be sure that the terms comply with the Board's policies.
- The LEOFF 1 Disability Board Annual Newsletter contains information on who is on the Board, insurance information, long-term care rate updates, and Medicare Part B enrollment and reimbursement procedures. This newsletter was recently distributed to LEOFF 1 Members.
- Staff is in contact with Gallagher to address questions about dental coverage. This information will be shared at the next Board meeting.
