

CONSTRUCTION ALERT

2024 ADA Curb Ramp Improvements – Village Park Drive at 174th Place SE and 175th Place SE

December 2024

The City of Bellevue Transportation Department will be making improvements along Village Park Drive between 174th Place SE and 175th Place SE. We will replace the existing sidewalk corners with new ramps that comply with the Public Right-of-Way Accessibility Guidelines (PROWAG) under the Americans with Disabilities Act (ADA). We will also add two marked crosswalk across Village Park Drive.

What to expect

- **Construction schedule:** Construction is expected to begin in January 2025 and work will occur intermittently over approximately ten days.
- **Work hours:** 7 a.m. - 6 p.m. Monday to Friday
- **Traffic impacts:** Lane closures with one-way alternating traffic will be needed to complete this work. Please expect delays and use alternate routes if possible. Flaggers will be on-site to stop and direct people driving, walking and rolling safely around the work zone. Please follow flaggers' instructions.
- Temporary sidewalk detours will be in effect while ramps are under construction.

Work is weather permitting. Please note that construction schedules are subject to change. Thank you for your patience during construction and for doing your part to be safe near the work zone.



Funding

Construction funding comes from the city's Pedestrian Facilities Compliance Program. The overall project's estimated cost is \$450,000, which includes replacing or building 13 curb ramps at four different locations.

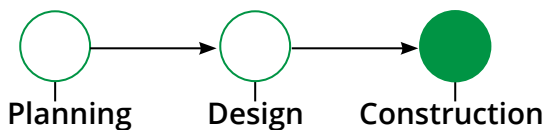
