#### I. CALL TO ORDER:

The meeting was called to order at 4:02 p.m. by Chair Noris.

#### II. ROLL CALL:

#### III. APPROVAL OF MEETING MINUTES:

Motion by Commissioner Jorgenson and second by Commissioner Parrish to approve the January 27, 2025 Civil Service Commission special meeting minutes as presented. Motion carried unanimously (5-0).

Motion by Commissioner Crowner and second by Commissioner Jorgenson to approve the March 12, 2025 Civil Service Commission special meeting minutes as presented. Motion carried unanimously (5-0).

#### IV. ORAL COMMUNICATIONS:

Chair Noris reviewed the guidelines for Oral Communications (Ordinance 6752).

Alex Tsimmerman, President of Stand Up America

Mr. Tsimmerman said that there is a critical situation because Mayor Robinson controls everyone. Mr. Tsimmerman was trespassed and everyone knows but no one stops the situation. Everyone is afraid of Mayor Robinson. Mayor Robinson has broken the Freedom of Speech Act.

#### VII. NEW BUSINESS:

#### A. Election of New Chair and Vice Chair

Chair Noris opened nominations for the Civil Service Commission Chair position.

Motion by Commissioner Sheffels to appoint Commissioner Crowner as the Civil Service Commission Chair.

Chair Noris requested other nominations for the Civil Service Commission Chair position. There were none. Therefore, nominations were closed.

At the question, motion carried unanimously (5-0) to appoint Commissioner Crowner as the Civil Service Commission Chair.

Chair Noris opened nominations for the Civil Service Commission Vice-Chair position.

Motion by Commissioner Jorgenson to appoint Commissioner Sheffels as the Civil Service Commission Vice-Chair.

Chair Noris requested other nominations for the Civil Service Commission Vice-Chair position. There were none. Therefore, nominations were closed.

At the question, motion carried unanimously (5-0) to appoint Commissioner Sheffels as the Civil Service Commission Vice-Chair.

#### B. Police:

i. <u>Lead Police Support Specialist Promotion Exam</u>

On behalf of the Police Department, Ms. Lorenzo made an official request to conduct a promotional exam for the rank of Lead Police Support Specialist. The Police Department does not currently have an active Lead Police Support Specialist eligibility list and there is one vacancy. Ms. Lorenzo responded to questions from Commissioners.

Motion by Commissioner Jorgenson and second by Commissioner Sheffels to approve the request to conduct a Police Lead Support Specialist Promotional Exam, as presented. Motion carried unanimously (5-0).

ii. Police: Modification to Selection Steps for Victim Advocate

iii. Police: Forensic Examiner – Recruitment

Major Inman noted that this will be an external job posting and the position will be available to all current City of Bellevue employees and the public. #### iv. Police: Forensic Lab Manager – Recruitment

A potential future vacancy in this position is anticipated and there is no current eligibility list. Major Inman noted that this will be an external job posting and the position will be available to all current City of Bellevue employees and the public. Motion by Commissioner Jorgenson and second by Commissioner Sheffels to approve the request to conduct a recruitment and hiring process for a Forensic Lab Manager, as presented. Motion carried unanimously (5-0).

#### v. Volunteer Program Coordinator Admin Assistant Recruitment

On behalf of the Police Department, Major Inman made an official request to conduct a recruitment and hiring process for a Volunteer Program Coordinator/Administrative Assistant. A potential future vacancy in this position is anticipated and there is no current eligibility list. Major Inman noted that this will be an internal and external job posting open to all non-Bellevue Civil Service employees. Major Inman responded to questions from Commissioners.

Motion by Commissioner Jorgenson and second by Commissioner Sheffels to approve the request to conduct a recruitment and hiring process for a Volunteer Program Coordinator/Administrative Assistant, as presented. Motion carried unanimously (5-0).

SUBJ: LETTER OF EXPLANATION; PROVISIONAL CAPTAIN MEDICAL SERVICES OFFICER (MSO)

As a result of a non-duty injury, the Fire Department needs to fill a position with a temporary appointment for one of our Medical Services Officer (MSO) assignments. The requirement is that this position is to be assigned as either a Lieutenant MSO or Captain MSO who has completed the MSO training book <u>and</u> who has been a King County trained paramedic or a staff member who has worked in the EMS Division as an administrative officer for a minimum of 2 years. Currently no internal candidates or any staff member on our Civil Service promotional lists meet these requirements.

To fill this gap and to meet the operational needs of the department, Bellevue Fire, as an appointing authority, will be appointing the following staff members to serve in this capacity:

- Lieutenant MSO Ron Rood to Provisional Captain MSO
- Firefighter/Paramedic Reese Cogdill to Provisional Lieutenant MSO
- The effective dates will be 6/16/2025 through approximately mid-August when the Captain MSO returns.

Local 1604 has been consulted and is supportive of this decision resulting in these assignments.

The department recognizes the need to bolster the depth of the candidate list for the MSO position, which is identified as a high priority for the Emergency Medical Services Division and one which will take some time to build the infrastructure.
