Presentation: Old Friends Club Affiliate Program

The purpose of Old Friends Club Affiliate program is to build a caring circle of connection for communities that are facing dementia. These individuals become increasingly isolated, then fearful, then agitated and must endure the stigma and diminishing control over their own lives. The care givers experience high levels of stress, depression, financial hardship, and strained relationships. There is an urgent need for a break to nurture the caregiver's well-being. To that end, Old Friends Club empowers communities to cultivate joy in the lives of adults with cognitive challenges and nourish the well-being of family caregivers by creating an environment within a person's community.

Old Friends Cub(OFC) is a 501c3 founded in 20215 to serve rural communities; it expanded to four respite programs by 2020; it served 130+ families; works as an extensive gap in dementia respite care. They now work to provide a toolkit for an expansion plan to equip other organizations to start their own community-based community-led OFC social respite program.

The purpose of this plan is to deliver meaningful engagement to people with dementia and respite caregivers through an Affiliate model that can be replicated and sustained by Affiliates in any community. There are no upfront costs for an organization to become and Affiliate and the OFCN receive funds from grants, sponsorships and donors to provide the service.

The OFC Social Respite Model is a place of friendship and belonging for people living with dementia-and a social respite program that provides family caregivers time for self-care. Each group allows up to 12 members and will utilize two staff members and volunteer guide for activities.

The OFCN is set up as:

- Social respite program aligned with OFCN values,
- OFCN provides toolkit and program guidance,
- Self-sustaining through modes user fees,
- OFCN provides ongoing training and support, without charge.

The OFC network is a collective, growing community of Affiliate Clubs around the county and state which OFC provides leadership stewards. What makes the OFC model different is the that similar programs have struggled to thrive and have dwindled in number, leaving a serious gap in respite care. OFCN creates a sustainable, replicable model and instills joy and resilience in community members dealing with dementia.

To financially set a group up, OFCN provides a budget template to help Affiliates tailor monthly fees. The group is set to be self-sustaining with just seven members. The group is affordable with room for a sliding scale to serve low-income families. Families are helped with budgeting for respite and encourage regular attendance. OFCN offers \$2,500 to help new nonprofit Affiliates with startup expenses. The program revenue covers all expenses, including part-time

staff to provide expertise and reliability. A Program Coordinator and a Program Assistant are the staff. The Assistant is a trained caregiver (CAN or equivalent). The two positions offer help not provided by most other social programs. Members can engage at the Club for much longer than they would have otherwise.

Ongoing training is completed at quarterly sessions by experts in the field. This ensure that staff and volunteer remain current and confident and if promotes peer support among Affiliate program staff.
