

NEP is...

- Council-directed, City-Funded, Capital Improvements
   Program
- Provides RESIDENTS the opportunity to PROPOSE and SELECT enhancement projects for their individual neighborhood area
- \$7 Million BUDGET distributed among 14 designated NEP neighborhood areas
- Area funds allocated based on the number of households in each Neighborhood Area
- Rotates through 14 Neighborhood areas over seven-year period – TWO AREAS per year (2023-2029)
- Program supported by multiple City departments –
   Community Development, Parks, Transportation, Utilities
- Currently 23 NEP projects in planning/progress around the city in twelve neighborhood areas





#### Provide your input on Eastgate's newest neighborhood park!

Join city staff for the first community meeting for Eastgate's newest neighborhood park on Thursday, Jan. 16, 6:30-8 p.m. at the South Bellevue Community Center. This event will offer community members a space to give feedback and input on plans for the upcoming park.

The Eastgate Neighborhood Area south of I-90 has long been underserved in parks and trails access. To address this need, voters passed the 2022 City of Bellevue Parks and Open Space levy, which generated funds for acquiring. planning and developing a new park in the Eastgate neighborhood

With these funds, the city acquired two properties on the corner of 147th Avenue SE and SE 39th Street, totaling about a half-acre of land for the proposed park.

We look forward to working with the community to plan and name the new park!



#### Why should I lock my doors?

The harder it is for a burglar to enter your home, the less likely it is that a burglary will occur.

No one should experience the feeling of a stranger rummaging through their things, especially when your home is where you should feel the safest. By always keeping your home locked, you are taking a simple but vital step to protecting yourself, your family, your valuables and your privacy. There are many circumstances of people falling victim to a home invasion that could have been prevented by simply locking up.

#### How do I develop safe habits?

It can be hard to remember to lock your doors, especially if it is not something you regularly do. Consider setting reminders on your phone, adding a sign to the door you see right before leaving or begin locking doors behind you as you walk

#### What if I leave and forget to lock my doors, or to close my garage door?

If you forget to lock your doors or are unsure if doors are locked and closed, smart locks are the solution! Bluetooth smart locks let you control your locks and garage doors from your phone.


#### Some helpful tips:

- have sturdy deadbolts and all windows are locked. Consider adding window security film for extra reinforcement.
- security system with cameras, alarms and you to any suspicious activity.
- Use outdoor lighting: Motion-activated lights around your home can illuminate dark areas and deter unwanted visitors.
- Trim Landscaping: Keep shrubs and trees well-trimmed to eliminate hiding spots near windows and doors.
- Create the illusion of occupancy: Use timers for indoor lights to mimic activity when you're not home or consider smart home devices that can simulate your presence.
- Reinforce entry points: Use door jammers or security bars on sliding doors. Reinforce doors with solid core materials.



### **PROJECT CRITERIA**

AFFORDABILTY

PROJECT COSTS MUST NOT EXCEED THE FUNDING ALLOCATION FOR THE NEIGHBORHOOD AREA

**CONSISTENCY** PROJECTS MUST BE CONSISTENT WITH CITY PLANS AND POLICIES

**FEASIBILITY** PROJECTS MUST BE PRACTICAL AND ACHIEVABLE FOR THE CITY

IMPLEMENTATION PROJECTS MUST BE DESIGNED AND CONSTRUCTED WITHIN 3-5 YEARS OF SELECTION

MAINTAINABILITY PROJECTS MUST NOT REQUIRE MAINTENANCE THAT IS BURDOMESONE TO THE CITY

**PUBLIC BENEFIT** PROJECTS MUST BE LOCATED ON PUBLIC PROPERTY, EASEMENTS, OR PROPERTY DESIGNATED FOR PUBLIC USE, AND MUST BENEFIT THE GENERAL PUBLIC
