2025 Fee Schedule for Plumbing Permits

Permits are required for the installation or relocation of fixtures. **NOTE**: A *fixture* is any appliance which connects to water, drain, or vent. *Replacement* of the following fixtures with like fixtures, in the same location, **does not require a permit**: wash basin, drinking fountain, urinal, bar sink, residential bidet, dishwasher, residential laundry tub, toilet, or kitchen sink.

NOTE: The Operations Fee is charged only once per permit.
