Garden d'Lights illuminates holidays with half a million lights

For more than three decades, Garden d'Lights has dazzled visitors at the Bellevue Botanical Garden. This beloved community event features over half a million sparkling lights formed into the whimsical shapes of plants, flowers, birds, animals and a meandering river, all set amid the natural beauty of the garden.

The tradition continues this year from Nov. 29-Dec. 31, excluding Christmas Day. On most nights during this time, visitors at the garden can also experience live music from local performers.

During Garden d'Lights, the Copper Kettle Coffee Bar will sell hot drinks and tasty treats at the Shorts House and the Trillium Gift Shop will be open as well.

Tickets

On general admission nights, tickets are \$10, and the show runs 4:30-9 p.m. Special discounted \$5 nights occur from Dec. 1-4 and Dec. 8-11, 4:30-8 p.m. Children 10 and under are always free. Tickets are date- and time-specific and must be purchased at **BellevueBotanical.org/garden-dlights**. They are not sold at the event.

Parking

Parking in the Botanical Garden lot is \$5 per car (cash or credit/debit card), or free with a state-issued disability parking permit. Free parking is available at Wilburton Hill Park, just a quarter of a mile east of the garden. Attendees can also use BellHop, the electric, on-demand, free shuttle service, to travel to the Garden from downtown Bellevue.

Volunteers make it happen

Approximately 130 volunteers contributed 6,400 hours over the previous 11 months to make this event happen. They created and installed a wide variety of botanically correct plants, animals and natural features using incandescent and energy-saving LED lights. Volunteers will also work at the event and take down the lights when the event ends.

Partnerships make it possible

Amazon is this year's presenting sponsor. The nonprofit Bellevue Botanical Garden Society (bellevuebotanical.org/bellevuebotanical-garden-society/), a partner with Bellevue Parks & Community Services in the year-round maintenance of the garden, produces Garden d'Lights. 

Stay engaged on the Affordable Housing Strategy

Nov. 6 info session, upcoming survey

As part of an ongoing effort to ensure housing is affordable for everyone across all incomes and backgrounds in Bellevue, the city is currently updating its Affordable Housing Strategy.

A public information session will be held Thursday, Nov. 6, 6-7:30 p.m., at City Hall. A public survey will be released following the Nov. 6 session.

The city's Office of Housing is managing the update, which will include new policy direction from the Bellevue's Comprehensive Plan update that was adopted last year. The updated plan includes five overarching housing goals for the city: affordable housing; housing equity; housing stability; housing for unique needs and housing supply and diversity.

The Affordable Housing Strategy update will identify actions to support the Comprehensive Plan's goals and help the city meet an overall target of building or preserving 5,700 affordable units in 10 years. Staff provided a progress report to the City Council in October and is releasing the draft strategy update in January.

Learn what's ahead for city and land use code updates

The City of Bellevue's Code and Policy team helps turn citywide goals and policies into the rules that guide how development happens. The team also updates the city's codes to align with new state laws and City Council priorities.

Fifth annual tree giveaway works to increase citywide tree canopy

Partners, staff and volunteers work through rainy weather to distribute 700 trees

During Bellevue's annual Tree Giveaway event last weekend, the city's Environmental Stewardship team partnered with 300 Trees and Amazon to distribute 700 free trees to residents and community organizations. Volunteers from the community braved the rainy and windy weather to help welcome tree recipients and load vehicles with trees, mulch and watering bags.

Although Bellevue reached its target of 40% tree canopy in 2021, the coverage throughout the city is not evenly distributed. With this in mind, the city's environmental team piloted a new application process this year, which targeted areas of the city that would benefit most from greater coverage. This year's process also gave recipients more environmentally well-suited tree species to choose from.

This marked the fifth year of Bellevue's program, which has given away nearly 4000 free trees to Bellevue community members since starting in 2021. Its continued success represents the city's ongoing commitment to environmental stewardship and sustainability.

Residents interested in receiving free trees during next year's event are encouraged to apply for the 2026 giveaway. Applications will open this summer.

Finding the right help for housing and property questions

Bellevue's Code Compliance officers serve as neighborhood stewards, helping maintain the safety, appearance and livability of our community. Their mission is to provide education and consistent, fair and equitable enforcement that promotes voluntary compliance and builds harmonious partnerships across Bellevue's diverse neighborhoods.

The Code Compliance team addresses a wide range of community concerns and responds to many issues that help keep Bellevue a safe and welcoming place to live.

- Construction and safety issues: Work done without required permits or abandoned and unsafe buildings.
- Home-based businesses: Ensuring home occupations follow city permitting requirements.
- Vehicles on private property: Inoperable or junk vehicles stored on private property.
- **RVs**, **boats and utility trailers:** There are storage and screening requirements in the city's land use code.
- Land use and zoning: Activities or uses that don't meet zoning or land use rules.
- **Nuisance and litter:** Debris, junk, or overflowing dumpsters that affect neighborhood cleanliness.
- **Noise:** Stationary noise from equipment such as heat pumps or air conditioners.

While the Code Compliance team handles a wide range of code-related issues, some matters—like landlord-tenant disputes or property line disagreements between neighbors—are considered private civil issues and not part of the city's code enforcement process. For these situations, the Bellevue Conflict Resolution Center is a valuable community resource.

Through the Housing Accord Program, the Conflict Resolution Center offers free, confidential and impartial services to help landlords and tenants resolve conflicts, strengthen communication and explore alternatives to eviction. The center also provides conflict coaching and negotiation services for neighbor-to-neighbor disputes, such as questions about shared fences or property boundaries.

Reaching out early can help bring understanding and resolution before conflicts grow.

Fall Reminder of the Importance of Preventing Falls

Each year, one-in-four Americans over the age of 65 experiences a fall. This is the leading cause of fatal and non-fatal injuries among older adults.

The encouraging news is that falls are not an inevitable part of aging. Many can be prevented with proactive measures and increased awareness. Here are some key strategies for older adults to prevent falls.

Stay physically active

Exercise programs that improve strength, balance and flexibility are crucial. Activities like walking, Tai Chi, yoga and chair exercises can help maintain muscle and joint strength, bone health and balance. The many parks in Bellevue provide safe walking paths and the city's Community Centers offer multiple opportunities for exercise classes. Review medications regularly

Certain medications, or combinations of medications, can cause side effects like dizziness or drowsiness, which increases the risk of falling. Older adults should review all medications—including over-the-counter drugs and supplements—with their healthcare provider or pharmacist.

Schedule vision and hearing checks

Even minor changes in sight or hearing can significantly impact balance and coordination. Regular check-ups ensure that prescription lenses and hearing aids are up to date.

Create a safe home environment

These simple home modifications can have a profound impact on safety.

- Remove tripping hazards from the floor, like throw rugs, clutter and extension cords
- Install grab bars in bathrooms

- Ensure lighting is bright enough throughout the home, especially during Autumn's shorter days
- Use non-slip mats in the shower and kitchen
- Place items used frequently in easy-to-reach place to avoid the need for a stepstool

Use assistive devices when needed

Properly fitted canes, walkers and other mobility aids can provide support for those who feel unsteady. Consult with a physical or occupational therapist to select and safely use the appropriate device.

Autumn is a season of change. Temperatures cool; days become shorter and leaves burst with color before falling to the ground. Let the falling leaves remind you to focus on your own fall prevention to reduce the risk and maintain independence.
