

Registered Sex Offenders

The Bellevue Police Department is releasing the following information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision in *State v. Ward*. This court decision authorizes law enforcement agencies to inform the public of a sex offender or kidnapping offender's release, when in the discretion of the agency, the release of information will enhance public safety and protection.

Unless explicitly stated, the sex offenders listed in this publication are **NOT WANTED BY THE POLICE AT THIS TIME**. This notification is not intended to increase fear; rather, it is Bellevue Police Department's belief that an informed public is a safer public. The Bellevue Police Department has no legal authority to direct where a sex or kidnapping offender may or may not live. Unless court ordered restrictions exist, these offenders are constitutionally free to live wherever they choose.

Sex offenders have always lived in our communities. It was not until the passage of the Community Protect Act of 1990, that law enforcement was notified where these offenders were living. In many cases, law enforcement is now able to share some of that information with you. It should go without saying, that citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notifications.

It is the Bellevue Police Department's practice to share with the citizens of Bellevue information related to all Level II and Level III registered sex offenders that have stated their intent to reside in the City of Bellevue, regardless of whether or not they have a fixed residence.

When an offender is released from custody and placed back to the community, they are evaluated to determine their risk classification level. This evaluation is based on a complex scoring and review process. Community safety is a primary factor in the process. The following is a brief explanation of Classification Levels:

- Level 1: These offenders present the lowest possible risk to the community and their likelihood to re-offend is considered minimal.
- Level 2: These offenders present a moderate risk to the community and they have a higher likelihood of re-offending than Level 1 offenders. They are considered a moderate risk to re-offend, because of the nature of their previous crimes, behaviors, and their lifestyle.
- Level 3: These offenders pose a potential high risk to the community and are considered a high risk to re-offend. Most have prior sex crime convictions and their lifestyles, behavioral choices, and tendencies place them in this classification.

The number of registered sex offenders residing in the City of Bellevue varies from month to month. In November 2025, there were 44 Level I offenders; 6 Level II offenders; and 2 Level III offenders, as well as 1 Kidnapping Offender.

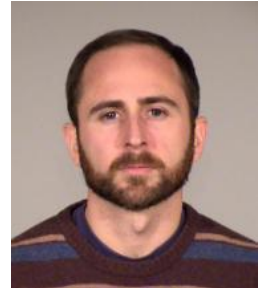
