Proposed speed cushions on 112th Avenue SE



The City of Bellevue is in the design phase of the South Bellevue Station Neighborhood Improvements Project. The project will fill in missing sidewalk gaps leading to the South Bellevue light rail station and install speed cushions on 112th Avenue SE. The speed cushions will be installed through the city's Pavement Preservation Program after the sidewalk is constructed. The speed cushions are in response to community concerns about speeding and aims to reduce high vehicle speeds along this road. In a community survey we sent to project area residents in December 2023, speed cushions were the most supported traffic calming measure. Speed cushions are like speed humps—both are proven measures to reduce vehicle speeds—except speed cushions have channels to allow for emergency response vehicles to travel with minimal delay.

There are five speed cushions planned along 112th Avenue SE between Bellevue Way and SE 34th Street. The approximate locations can be viewed on the map on the back of this page. The locations have also been marked in spray paint on the road. If a speed cushion is planned near your home, you'll receive a follow-up letter with more information within the next month. Construction is anticipated to begin in 2025 or 2026.
