## Downtown National Highway System (NHS) Overlay



February 2025

The Downtown National Highway System (NHS) Overlay project is a component of the city's Pavement Preservation Program. This project will provide major street preservation to NE 8th St, NE 4th St and Bellevue Way, all three of which are roads that belong to the Federal Highway Administration's National Highway System (NHS). NHS roads are important connectors to the interstate system (I-405, I-90) and public transportation facilities (Bellevue Transit Center).

Work includes street overlays, pavement rehabilitation, curb, gutter, and sidewalk or walkway rehabilitation, and appropriate Americans with Disabilities Act (ADA) retrofit work.

### Description

This project will:



**Grind and overlay (repave) roads on portions of NE 8th, NE 4th and Bellevue Way**



**Upgrade existing curb ramps within the project limits to meet ADA requirements to the maximum extent feasible**

Este proyecto proveerá un importante mantenimiento de las calles NE 8th St, NE 4th St y Bellevue Way. Las obras incluyen la repavimentación de calles y el arreglo de bordillos, canaletas y aceras. Se espera que las obras comiencen en marzo de 2025 y se prolonguen hasta finales del verano de 2025. Tenga en cuenta que los horarios de obras pueden cambiar y a menudo lo hacen.

### Project Schedule

Construction is anticipated to start in March 2025 and take until the end of summer 2025. Please note that construction schedules are subject to change and often do.

### Traffic Impacts

Pavement work will primarily take place overnight between the hours of 7 p.m.–6 a.m. Expect traffic shift to one side of the roadway during nighttime working hours. Curb ramp replacements work will occur during the day.

### Funding

The estimated cost of construction is \$7.8 million. Funding sources include \$7 million in federal with the remaining \$800,000 provided by city funds.


