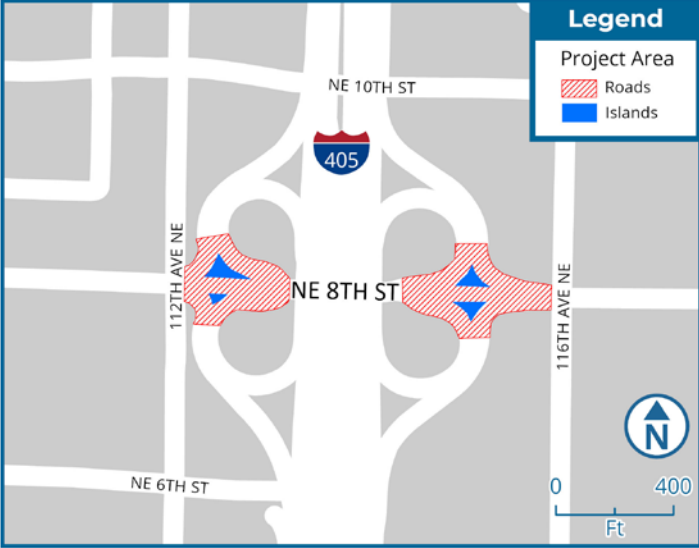




# Construction Alert

## NE 8th Street and I-405 Crossing Improvements

March 2025



The City of Bellevue Transportation Department has an upcoming project to improve the experience and safety of people walking and rolling along NE 8th Street over I-405. This project will also improve the look of this crossing, which serves as a gateway into downtown Bellevue.

The Bellevue Transportation Department plans to:

- Install new marked crosswalks
- Install and upgrade curb ramps
- Install new flashing beacons at the crossings
- Add landscaping to traffic islands

### What to expect

- **Schedule:** Construction is anticipated to start at the end of March and will take approximately five months to complete.
- **Work hours:** Work will happen nightly, 9 p.m.-5 a.m. Sunday to Thursday. There will also be a maximum of six weekends of work, 9 p.m. Friday to 5 a.m. Monday.
- **Traffic impacts:** I-405 ramp closures and detours will be needed to complete this work. All ramp closures will happen during the work hours described above and will be posted on the city's Traffic Advisories page at [BellevueWA.gov/trafficadvisories](http://BellevueWA.gov/trafficadvisories).
- **Access for people walking and rolling and access to businesses will be maintained during construction.**

Please note that construction schedules are subject to change. Thank you for your patience during construction and for doing your part to be safe near the work zone.

### Funding

This project is funded by the Neighborhood Safety, Connectivity and Congestion Levy. The cost of construction is approximately \$2.4 million.

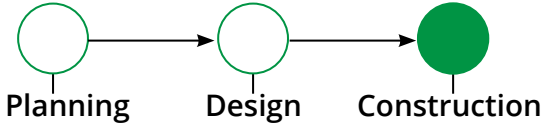
