## South Bellevue Station Neighborhood Improvements Project



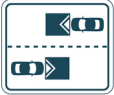

The City of Bellevue Transportation Department has an upcoming project in your area to improve the experience and safety of people walking. This project will fill in missing sidewalk gaps leading to the South Bellevue light rail station and install speed cushions on 112th Avenue SE. The speed cushions are being installed in response to community concerns about speeding. Speed cushions were selected through a community survey in 2024.

The Bellevue Transportation Department plans to:



Install new sidewalks on SE 34th Street, 112th Avenue SE and 113th Avenue SE



Install five new speed cushions on 112th Avenue SE



Install new landscaped areas



Upgrade storm drainage



Repave portions of Bellevue Way SE, 110th, 111th, 112th and 113th Avenues SE, SE 28th, 30th, 31st and 34th Streets, SE 28th and SE 30th Places



Install two patterned entry treatments on 112th Avenue SE

### What to expect

- **Schedule:** Construction is anticipated to start in May and be completed later this summer. The speed cushions and repaving are happening as part of the Pavement Preservation Program and may happen after the sidewalk construction is complete.
- **Work hours:** Monday to Friday, 8 a.m.-4 p.m. There will also be some night work for paving Bellevue Way SE in front of the South Bellevue Park and Ride.
- **Traffic impacts:** There will be lane closures along SE 34th Street with flaggers directing traffic. There will also be some lane closures near the South Bellevue Park and Ride during the night work. Access for people walking and rolling will be maintained.

Please note that construction schedules are subject to change. Thank you for your patience during construction and for doing your part to be safe near the work zone.

### Funding

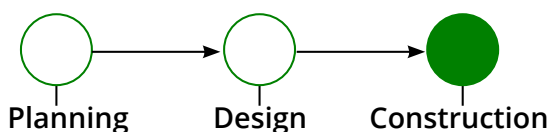
Funding for this project comes from the Neighborhood Sidewalks Program, Pavement Preservation Program, and Neighborhood Safety, Connectivity and Congestion Levy. The estimated cost is approximately \$4 million.

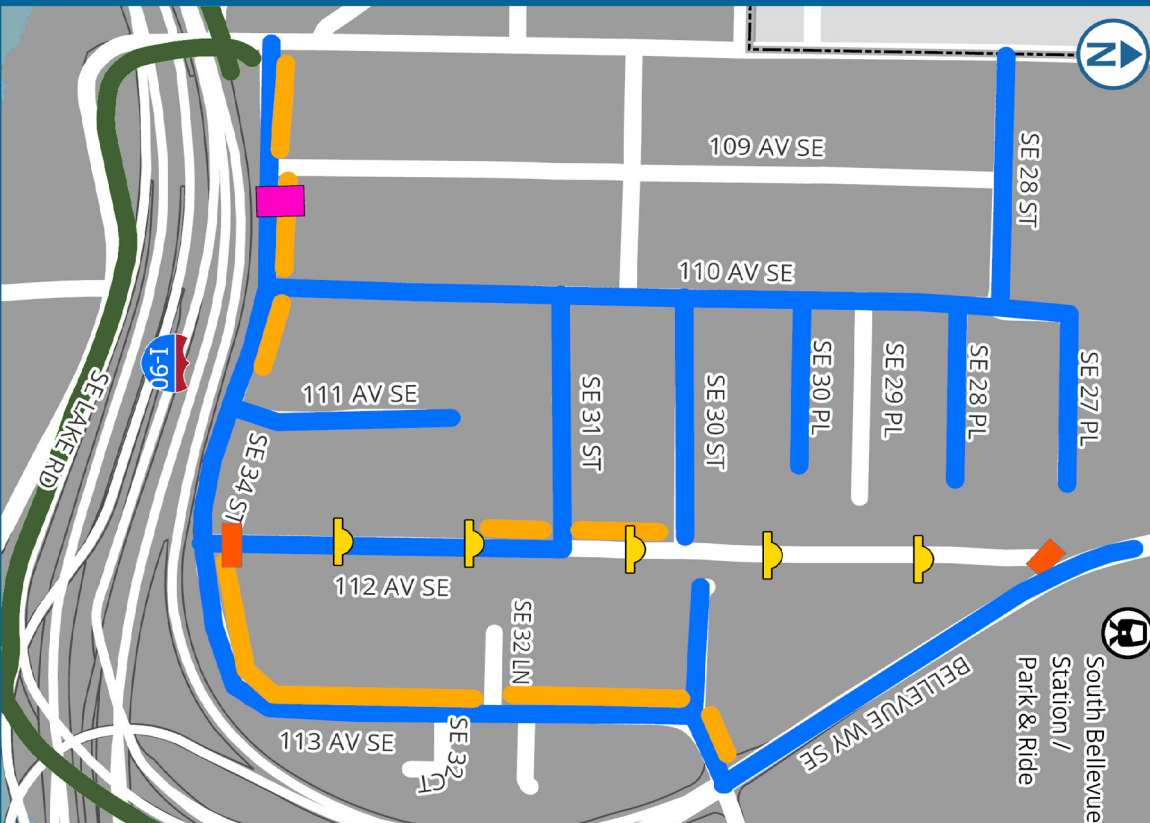
