

Tyee Community Gym Rental Conditions of Use

CONDITIONS OF USE - All applicable conditions of use must be shared with all rental attendees:

A Facility Staff member will be at the gym to provide access at the start-time indicated on your agreement. Rental time is based on the time of the staff's cell phone. The clock on the wall is not always reliable.

RENTAL MAIN CONTACT is responsible for meeting the Facility Staff at the gym, if you will not be the person at the gym, please provide the name of the person that will be at the gym.

DAY OF RENTAL should a problem arise at the facility call the PSO Concern Line at 425-452-7859. Leave a message and your call will be returned.

FACILITY RENTAL GUIDELINES contain requirements, cancellation & reschedule policies as well as responsibilities, park facilities codes and more.

USE OF TOBACCO, ALCOHOL, FIREARMS or CONTROLLED SUBSTANCE PRODUCTS is prohibited by state law on school property, including buildings, parking lots and grounds.

EQUIPMENT will be your responsibility to set-up and take-down i.e., poles, nets, chairs, and tables. You must bring your own sports balls. If using the volleyball equipment, it must be left in the condition that you find it, so it is ready for Bellevue Parks program use. <u>Antennas, clips, etc., are not to be removed</u>.

STORAGE ROOMS are for Facility Staff access only. Rental guests should not be inside or access equipment without staff permission.

<u>CLEAN-UP</u> including sweeping the gym is required to be completed during scheduled rental time. Cleaning equipment is available. Sweeping is not required if you are the last group of the day, unless otherwise instructed by Facility Staff.

FOOD & DRINK is restricted inside the gym. Drinking fountain availability is not guaranteed. Beverages in bottles with lids are allowed inside the gym. Food is only allowed in the small, carpeted area by the restrooms or outside.

SPITTING is prohibited in the gym. Please DO NOT spit in the drinking fountain, trash cans, or bathroom sinks.

GUM is prohibited in the gym.

GYM SHOES are required for all sports activities; black soled shoes are prohibited due to scuffing of floor.

PARKING is first-come, first-served, and all vehicles must vacate lot at the end of rental. Vehicles are subject to being towed if left overnight. Please be a good neighbor if parking on the street, do not block driveways.
