Sidewalk installation and crosswalk and lighting enhancements

Project Description:

The Bellevue Transportation Department is enhancing pedestrian connectivity and safety with the following improvements:

- Install Rectangular Rapid Flashing Beacon (RRFB) system at the existing crosswalks on 156th Avenue NE at NE 4th Street and NE 6th Street.
- Build new sidewalk on the east side of 156th Avenue NE between NE 1st Place and NE 1st Street.
- Install a new crosswalk with a RRFB system at NE 1st Street.

Construction Area:

On 156th Avenue NE between Main Street and NE 6th Street. (See map on reverse side.)



Construction Funding:

The project is funded by the Neighborhood Safety, Connectivity and Congestion Levy. Construction cost is approximately \$420,000.
