Eastgate/Factoria

Thank you for participating in the Eastgate/Factoria Neighborhood Enhancement Program! In March, 400 households selected their top three, of 26, proposed enhancement projects to receive Neighborhood Enhancement Program (NEP) funds. A total of **five** projects will be funded with the \$293,000 Eastgate/Factoria NEP allocation, which will also include associated planning, design, labor and materials fees.

As we begin the implementation phase, we encourage you to remain engaged in the process by contacting project managers to provide input, tracking the status of the projects on the NEP website, and enjoying the built work!

The following projects received the highest scores and will be funded and implemented by the Neighborhood Enhancement Program over the following three years.

EF-25: 150th Avenue SE Walkway \$75,000 204 points

150th Avenue SE, north of SE Newport Way

This project will install segments of curbed asphalt walkway and delineated path on the west side of 150th Avenue SE, north of SE Newport Way.

EF-5: SE 38th Street Gateway Landscaping \$100,000 179 points

SE 38th Street, between 150th and 154th Avenues SE

This project will remove blackberry shrubs and other vegetation along the north and south sides of SE 38th Street, between 150th and 154th Avenues SE, and replace them with new shrubs and trees. Irrigation will be installed, existing sidewalks will be cleaned, trees in poor condition will be removed, and trees in good condition will be pruned.

EF-11: Horizon Heights Streetlights \$40,000 138 points

152nd Place SE; SE 44th Place; 153rd Avenue SE

This project will install three, new streetlights in the Horizon Heights neighborhood, including new poles, LED streetlights, and connections to underground power. Exact light locations will be determined with the community.

EF-14: Lattawood Park Lighting \$30,000 127 points

Lattawood Park

Staff have identified an opportunity to integrate the request for path lighting with a public art project planned for the Lattawood Park. Merging these two projects will preserve park space and provide lighting in a way that engages park users, while also enhancing pedestrian accessibility and safety. Funding for the art will supplement the NEP funding designated for the lighting.

EF-2: 152nd Avenue SE & 152nd Place SE Trail \$30,000 122 points

152nd Place SE to 152nd Avenue SE

This project will install a stairwell to improve the safety of, and access to, the trail between 152nd Place SE and 152nd Avenue SE.
