RE: Ecology's Notice of Final Action on City of Bellevue Shoreline Master Program Comprehensive Update and Periodic Review

Dear Interested Parties:

The Washington State Department of Ecology (Ecology) is pleased to announce its final action approving the city of Bellevue's (City) Shoreline Master Program comprehensive update and periodic review. The effective date of the City's updated SMP is August 6, 2018. Ecology will publish a notice (legal ad) that starts a 60-day appeal period. The expected date of publication in the Seattle Times is August 6, 2018.

The following correspondence regarding the recent SMP amendment took place between Ecology and the City:

- January 25, 2016 Ecology accepted the City's locally adopted SMP update and periodic review as complete for purposes of review (Resolution No. 8922).
- June 1. 2017 Ecology conditionally approved the City's proposed SMP with specific required changes.
- June 15, 2018 The City sent a letter to Ecology accepting 8 of Ecology's required Changes and proposed alternative language for the remaining 8 required changes (Ordinance No. 6416). In addition, the City accepted 9 recommended changes, proposed alternative language for 4 recommended changes, rejected 6 recommended changes, and requested alternative language for 7 additional items.
